The follow-up and review of the 2030 Agenda for Sustainable Development at the annual ECOSOC High-Level Political Forum on Sustainable Development (HLPF) is one such space to embrace the interdependence of the three dimensions of sustainable development (environmental, social and economic), including through thematic reviews of individual SDGs and their interlinkages with other Goals, and through Voluntary National Reviews of SDG progress.

Your special attention to the SDGs that are under review at the HLPF this year, namely SDG 6 (clean water and sanitation), SDG 7 (affordable and clean energy), SDG 9 (industry, innovation and infrastructure), SDG 11 (sustainable cities and communities), and SDG 17 (partnership for the goals) is especially appreciated.

There are clear connections among these Goals that can motivate cross-cutting actions – for example, the role of consistent energy supply for the development of manufacturing capabilities and increasing employment in manufacturing; the role of industrial capacity and robust infrastructure for the provision of clean water and sanitation; and the role of partnerships for sustainable urban living.

Your valuable deliberations will also serve as an important stepping stone to the upcoming midterm review of all the SDGs at the SDG Summit in September.

As we reset over the next seven years, we can draw confidence from the fact that we have access to more knowledge, technologies and resources than ever before. Our efforts can be focused on working together to leverage these to the maximum effect.
