Funding

- The meeting <u>will not</u> entail implications for the regular budget. It will be supported through extra-budgetary resources, with the support of the Government of Chile, the Economic Commission for Latin America and the Caribbean (ECLAC), and the United Nations Development Programme (UNDP).
- Travel funding will be available to <u>one high-level representative</u> of 2024 ECOSOC Member States from <u>LDCs, LLDCs, and SIDS, as well as from developing countries, on a case-by-case basis</u>. The funding will cover economy-class round-trip air tickets and accommodation.
- The process for the selection of representatives and the provision of travel support <u>will be communicated to</u> <u>those who have registered</u> to participate in the meeting and indicated their request for eligible funding in the registration form.
