#### H.E. Mr. Akan Rakhmetullin, Permanent Representative of Kazakhstan to the United Nations, Vice-President of the Economic and Social Council responsible for the Coordination Segment

His Excellency Akan Rakhmetullin, is the Ambassador and Permanent Representative of the Republic of Kazakhstan to the United Nations in New York, assuming his duties on 26 October 2022.

Prior to his appointment, Mr. Rakhmetullin was his country's First Deputy Minister for Foreign Affairs from April to October 2022 after having served as Deputy Minister for Foreign Affairs since 2021. He was

Ambassador to Pakistan from 2019 to 2021, Director of the Department of Multilateral Cooperation of the Ministry of Foreign Affairs from 2015 to 2019 and Deputy Permanent Representative of Kazakhstan to the United Nations in New York from 2011 to 2015.

Mr. Rakhmetullin served as his country's Deputy Permanent Representative to the Organization for Security and Co-operation in Europe (OSCE) in Vienna from 2007 to 2011; Counsellor and Deputy Director of the Department of International Humanitarian and Economic Cooperation of the Ministry of Foreign Affairs from 2004 to 2007; and First Secretary at the Permanent Mission of Kazakhstan to the United Nations in New York from 2002 to 2004.

Mr. Rakhmetullin graduated with honours from the Diplomatic Academy of the Ministry of Foreign Affairs of Kazakhstan in 1999.



## H.E. Ms. Paula Narváez, Permanent Representative of Chile to the United Nations, President of the Economic and Social Council

Her Excellency Paula Narváez was elected the seventy-ninth President of the Economic and Social Council on 27 July 2023.

Ambassador Paula Narváez is currently the Ambassador and Permanent Representative of Chile to the United Nations in New York. Her Excellency Paula Narváez assumed her duties as

Permanent Representative of Chile to the United Nations on 08 June 2022.

Before this latest appointment, Ms. Narváez was the Officer-in-Charge at the United Nations Entity for Gender Equality and the Empowerment of Women (UN-Women) in Guatemala, from February to May 2022. She also served as Socio-Political Adviser at the UN-Women Regional Office for Latin America and the Caribbean, from October 2021 to February 2022, and Regional Adviser for Governance and Political Participation in the same office, from 2018 to 2020. Between 2016 and 2018, Ms. Narváez was Minister Secretary General of Government, and she served as a Presidential Adviser from 2014 to 2016. From 2012 until 2014, she was a Latin America and Caribbean Section Program Specialist at UN-Women, based in New York. Following the eruption of the Chaitén Volcano in Chile in May 2008, Ms. Narváez served as the delegate of then-President Michelle Bachelet to the Chaitén Volcano Emergency, from 2008 to 2009. She has also held a number of other Government positions.



Ms. Narváez earned a master's degree in Latin American Studies from Georgetown University in the United States; a master's degree in economics and regional management from the Universidad Austral de Chile; and a degree in psychology from the Universidad Nacional Andrés Bello, also in Chile.



# H.E. Mr. Earle Courtenay Rattray, Chef de Cabinet, Executive Office of the Secretary-General (EOSG), United Nations

United Nations Secretary-General António Guterres announced on 17 December 2021 the appointment of Courtenay Rattray of Jamaica as his Chef de Cabinet.

Mr. Rattray has been High Representative for the Least Developed Countries, Landlocked Developing Countries and Small Island Developing States since July 2021. Prior to this appointment, he served as Permanent Representative of Jamaica to the United Nations in New York, during which time, he was also Cochair of the Group of Friends of the Sustainable Development Goals (SDGs) Financing; Children and the SDGs; and the Group of Friends of Decent Work.

He previously served as Jamaica's Ambassador to China (2008-2013); Director of the Bilateral Relations Department in the Ministry of Foreign Affairs and Foreign Trade in Kingston (2005 -2008); Deputy Chief of Mission, Embassy of Jamaica in Washington, D.C., (2001-2005); Special Adviser to the Minister for Foreign Affairs and Foreign Trade (2000-2001); and Special Adviser to the Minister for Industry and Investment (1999-2000). Before he joined the foreign service, he served as Executive Director of the Jamaica Marketing Company in London (1990-1997) and Director of Marketing and Promotions at the Jamaica National Export Corporation in Kingston (1987-1988).

Mr. Rattray holds a Master of Arts degree from the Fletcher School of Law and Diplomacy at Tufts University in the United States, a Master of Arts in International Business from the London South Bank University and a Bachelor of Arts in International Studies from West Virginia Wesleyan College in the United States. He was awarded a Doctor of Humane Letters (Honoris Causa) by West Virginia Wesleyan College.



# Mr. Darío José Mejía Montalvo, Political Scientist, National University of Colombia, and Chair of the Permanent Forum on Indigenous Issues (PFII) at its 22nd session

Mr. Mejia Montalvo belongs to the Indigenous Zenú Peoples of San Andres Sotavento. He is a Political Scientist from the National University of Colombia, with a Master's degree in Management of Development conferred by University of the Autonomous Regions of the Nicaraguan Caribbean Coast (URACCAN). He is a lecturer and consultant for different organizations and institutions. He is also a member of the National Commission for Labor and Coordination of Education of the Indigenous Peoples of Colombia – CONTCEPI.

Mr. Mejia Montalvo is the leader of the National Indigenous Organization of

Colombia (ONIC). From 2008 to 2012, Mr. Mejia served as ONIC Counselor of Education. Additionally, he is a former member of the Board of Directors of the Fund for the Development of Indigenous Peoples of



Latin America and the Caribbean, and the Technical Secretary of the Permanent Dialogue Mechanisms between the National Government and the Indigenous Peoples of Colombia. In 2014, Mr. Mejia Montalvo coordinated the conclusion of the 1953 Decree, the Indigenous component of the National Development Plan. Additionally, he supported the "Fast Track" procedure within the framework of the Final Peace Accord.



## Mr. Luis Felipe Lopez-Calva, Global Director for Poverty and Equity, World Bank Group

Mr. Luis Felipe López-Calva has over 30 years of professional experience working with international institutions and advising national governments. He rejoined the World Bank in 2022 from the United Nations Development Programme, where he served as UN Assistant Secretary General and Regional Director for Latin America and the Caribbean since 2018.

In his previous tenure at the World Bank, he held various positions

including Practice Manager of the Poverty and Equity GP for Europe and Central Asia, Co-Director of the World Development Report 2017 on Governance and the Law, Lead Economist and Regional Poverty Advisor in the Poverty and Equity GP for Europe and Central Asia, and Lead Economist in the Poverty, Equity and Gender Unit in the PREM Directorate for Latin America and the Caribbean. He has led lending projects in policy operations for 1.1 billion USD.

His research interests focus on labor markets, poverty and inequality, institutions, and the microeconomics of development. He has published on these issues in peer-reviewed academic journals, such as The Journal of Development Economics, The Journal of Economic Inequality, World Development, Economics Letters, Oxford Economic Papers, and Oxford Development Studies, among others. He has also published widely cited books and policy reports. He holds a Master's degree in Economics from Boston University, as well as a Master's and a PhD in Economics from Cornell University.



## Ms. Diene Keita, Deputy Executive Director of United Nations Population Fund (UNFPA)

Ms. Diene Keita is the United Nations Assistant Secretary-General and Deputy Executive Director of the United Nations Population Fund. Prior to this, she served as Minister of Cooperation and African Integration of the Republic of Guinea, and brings to this position nearly 30 years of experience including senior leadership with the United Nations.

Ms. Keita first joined to the United Nations System in 2006 as UNDP Program Officer in New York. Subsequently, she served as UNDP Deputy Representative in Africa and the Caribbean, and Representative to the African Union in Addis Ababa.

During her tenure at UN System, Ms. Keita served as UNFPA Representative

in Mauritania, Benin, DRC and Nigeria (two of UNFPA's largest programs worldwide). Concurrently, she was the UN Resident Coordinator in Mauritania, Benin and DRC. During this period, Ms. Keita led with



success large and complex public health programs, expanded strategic partnerships and mobilized critical resources to support efficient delivery at local and global level.

Throughout her career, Ms. Keita has worked extensively on women and youth empowerment, inclusive growth, demographic issues and sustainable human development, sexual and reproductive health, as well as gender-based violence issues in the context of humanitarian crises.

Dr Keita holds a doctorate in law, summa cum laude, a DEA in international economics and development law, and a DESS in international relations from the University of Paris 1 Panthéon Sorbonne and is fluent in English, French and Italian, among other languages,



## Ms. Paola Albrito, Acting Special Representative of the Secretary-General for Disaster Risk Reduction (UNDRR)

Concurrent with her role as Director of the UNDRR Office, Ms. Albrito comes with extensive experience in supporting disaster resilience and sustainable development policies and instruments in Africa, Europe and Central Asia. Her broad expertise includes the development of policy guidance, cross-government strategy development, and high-level advocacy. Ms. Albrito has risen

through the ranks at UNDRR, where she previously served as the Chief of the Intergovernmental Processes, Interagency Cooperation and Partnership Branch at UNDRR's headquarters in Geneva. In that capacity, she steadily built new partnerships and renewed traditional ones, both within the UN system and with stakeholder groups. Before moving to Geneva, she led the UNDRR Regional Office for Europe and Central Asia in Brussels, which covers 55 countries. During her tenure, she elevated the disaster risk reduction agenda to the highest political levels within the Europe region. Prior to joining UNDRR in 2004 and as part of her experience in the Djibouti Resident Coordinator's office, she developed and coordinated policy guidance, facilitated climate adaptation and development strategies, and she acted as the focal point for humanitarian appeals, emergency, and rapid response. Her past experiences also include time with the International Labor Organization and the United Nations Staff System College.



#### H.E. Ms. Noemí Espinoza Madrid, Deputy Head of Mission, Embassy of Honduras in the People's Republic of China, and Chair of the Commission on Population and Development

Her Excellency Noemí Espinoza Madrid has over 25 years of experience working on political advice, advocacy, partnerships, and strategic guidance for top level government and intergovernmental organizations, mostly at the United Nations. She has been a leader in intergovernmental negotiations both as an Ambassador and a UN advisor. She is known for establishing and galvanizing partnerships with civil society and governments to advocate for human rights and for political, economic, and cultural justice. She is a sought out lecturer for academic conferences and universities. She began her diplomatic career in the Honduran Consulate in New York City in 1996. She has served in various capacities at the Permanent Mission of Honduras and

has a long career in the United Nations Secretariat, where she has been a Senior Advisor to the United



Nations President of the General Assembly and Special Advisor to the Secretary-General's Envoy on Youth. Ambassador Espinoza Madrid holds two M.A.s. one in Economics from Vanderbilt University and a second one in Politics from The New School.



# Mr. Maximo Torero, Chief Economist, Food and Agriculture Organization of the United Nations (FAO)

Mr. Torero joined FAO in January 2019 as Assistant Director-General for the Economic and Social Development Department. Prior to joining FAO, he was the World Bank Group Executive Director for Argentina, Bolivia, Chile Paraguay, Peru and Uruguay since November 2016 and before the Bank Mr. Torero led the Division of the Markets, Trade, and Institutions at the International Food Policy Research Institute (IFPRI). His major research work lies mostly in analyzing poverty, inequality, importance of geography and assets (private or public) in explaining poverty, and in policies oriented towards poverty alleviation based on the role played by infrastructure,

institutions, and on how technological breakthroughs (or discontinuities) can improve the welfare of households and small farmers. His experience encompasses Latin America, Sub-Saharan Africa, and Asia.

Mr. Torero, a national of Peru, holds a Ph.D. and a Master's degree in Economics from the University of California, Los Angeles (UCLA), and a Bachelor's degree in Economics from the University of the Pacific, Lima, Peru. He is a professor on leave at the University of the Pacific, Perú, and an Alexander von Humboldt Fellow at University of Bonn, Germany, and has also published in top journals (QJE, Econometric Theory, AER-Applied Microeconomics, RSTAT, Labor Economics and many other top journals). Mr. Torero has received in 2000 the Georg Foster Research Fellowship of the Alexander von Humboldt Foundation, won the Award for Outstanding Research on Development given by the Global Development Network, twice, in 2000 and in 2002, and received the Chevalier de l'Ordre du Mérite Agricole in 2014.



## Mr. Omar Abdi, Deputy Executive Director, United Nations Children's Fund (UNICEF)

Mr. Abdi oversees UNICEF's global humanitarian and development programmes.

## Ms. Melissa Fleming, Under-Secretary-General for Global Communications, United Nations

Melissa Fleming is Under-Secretary-General for Global Communications at the United Nations, having taken up her post in September 2019.

Ms. Fleming leads the UN's <u>Department of Global Communications</u>, which is responsible for informing global audiences about the state of the world and engaging them to build support for the Organization's work and goals. In this role, Ms. Fleming oversees the UN's strategic communications operations, including its multilingual news and digital media services, public outreach programmes, and global campaigns.

Under her leadership, the UN Department of Global Communications engages in far-reaching efforts to address misinformation, disinformation, and hate speech. She is leading on the development of a Code of Conduct for Information Integrity on Digital Platforms.

Previously, Ms. Fleming served 10 years at the UN Refugee Agency (UNHCR) as Head of Global Communications. Prior to that, she was the Spokesperson and Head of Media and Outreach at the International Atomic Energy Agency (IAEA). She also headed the Press and Public Information team at the Organization for Security and Co-operation in Europe (OSCE). Ms. Fleming is a <u>TED speaker</u>, the author of the book, <u>A Hope More Powerful than the Sea</u>, and the host of the award-winning UN podcast, <u>Awake at Night</u>.

Ms. Fleming holds a Master of Science in Journalism from the College of Communication, Boston University and a Bachelor of Arts in German Studies from Oberlin College.

Ms. Ana Cristina Amoroso das Neves is passionate about Digital World, Emerging Technologies, RTD & Innovation Public Policies, Strategy, Diplomacy, with over 30 years of professional experience in these areas, while developing strategic and tactical thinking. Set-up and facilitated initiatives to leverage digital emerging technologies and competences to improve services and its use by a range of different stakeholders. Has

been very active on the further disruption of existing social and political power structures within Internet policy evolution, while negotiating with different stakeholders, within complex governance structures. Currently, Ana Crisitina Amoroso das Neves is Head of the Internet Governance Office, Chair of the CSTD (UNCTAD) and President of the Advisory Council of DNS .PT. She previously was Advisor to the Minister of Science, Technology and Higher Education (DEC19-MAR22), while Executive Coordinator PERIN (Portugal in Europe Research and Innovation Network). Prior to that she was Director at the Department of Information Society, Science and Technology Foundation and responsible for the coordination of Information Society under the competences of the Foundation for Science and Technology, I.P. Ana Crisitina Amoroso das Neves held several other positions such as a former expert, invited by the European Commission, to the Horizon2020 (H2020) Advisory Groups (AG) on Future & Emerging Technologies,



International Cooperation and Climate action, environment, resource efficiency and raw materials, and former PT delegate, Future Internet Forum, and Digital ERA Forum among others. Ana Cristina Amoroso das Neves is also the former Head of International Affairs at Knowledge Society Agency (UMIC) and the former Vice-Chair of the EU Strategic Forum for International Cooperation on Science & Technology and Chair of its Task Force.



# Ms. Ligia Noronha, Assistant Secretary-General, United Nations Environment Programme (UNEP)

Ms. Ligia Noronha began her role as United Nations Assistant Secretary-General and Head of the New York Office at UNEP on 1 April 2021. In this role she works in establishing and maintaining critical links with the Permanent Missions of Member States to the United Nations, the United Nations Secretariat, other UN System organizations and entities headquartered in New York, major groups, civil society organizations, academia and the private sector. Through her leadership of the New York Office, she seeks to promote effective integration of the environmental

dimension in the UN System, in the inter-agency mechanisms and in the intergovernmental processes while raising awareness of emerging environmental issues and the outcomes of the United Nations Environment Assembly.

An economist with over 30 years of international experience in the field of sustainable development, Ms. Noronha previously served as Director of UNEP's Economy Division based in Paris and Nairobi, leading UNEP's work on climate mitigation and energy transitions; on inclusive green economies, circularity and sustainable consumption and production, as well as on trade and sustainable finance; on extractives, and the nexus of environment, pollution and health. During her tenure, Ms. Noronha positioned the Economy Division as a center for integrated actions in support of the 2030 Agenda.

Prior to joining UNEP, Ms. Noronha worked as Executive Director at The Energy and Resources Institute (TERI) in New Delhi; she served as Secretary of the Asian Energy Institute and as Coordinator of the Renewable Energy and Energy Efficiency Partnerships (REEEP), and worked with the International Development Research Centre (IDRC), Canada.



# Mr. Jorge Moreira da Silva, Executive Director, UN Office for Project Services (UNOPS)

Appointed by the UN Secretary-General António Guterres on 23 March 2023 as Executive Director of the United Nations Office for Project Services (UNOPS), Mr. Jorge Moreira da Silva of Portugal was formerly a Visiting Full Professor at the Faculty of Engineering of Oporto University and Adjunct Professor at the Paris School of International Affairs (Sciences Po).

He was most recently Director of the Development Co-operation Directorate of the Organisation for Economic Co-operation and Development (OECD) in Paris (2016-2022), where he successfully launched and led a restructuring of the Directorate with the objective of boosting horizontality, collaboration and co-creation. As Head of the Secretariat of the Development Assistance



Committee, he anchored the formulation of new standards on development cooperation and humanitarian aid.

Before joining OECD, Mr. Moreira da Silva was the Minister for Environment, Energy and Spatial Planning of Portugal from 2013 to 2015 and Visiting Full Professor at the Lisbon University. Prior to his ministerial position, he served as Senior Environmental Finance Adviser and Programme Manager on Climate Change Innovative Finance at the United Nations Development Programme (UNDP) (2009-2012); Senior Adviser to the President of Portugal on Science and Environment (2006-2009); Secretary of State for Environment and Spatial Planning (2004-2005); Secretary of State for Science and Higher Education (2003-2004); and Member of the Portuguese Parliament and Member of the European Parliament (1999-2003), where he authored the legislation that created the European Union Green House Gas Emissions Trading Scheme.



## Ms. Sarah Hendriks, Deputy Executive Director for Policy, Programme, Civil Society, and Intergovernmental Support a.i., UN-Women

Ms. Sarah E. Hendriks was appointed UN Women Deputy Executive Director for Policy, Programme, Civil Society, and Intergovernmental Support, a.i., on 1 June 2023.

Ms. Hendriks is a visionary leader in global cooperation and development with more than 25 years in programme and policy work on gender equality. With extensive experience in leadership and strategy design, Ms. Hendriks supported the development and execution of UN Women's new Strategic Plan 2022–2025 within six geographic regions and across the core impact areas of governance and participation; ending violence against women; economic empowerment; peace, security and resilience; and humanitarian action. Ms.

Hendriks provided overarching leadership to UN Women's global response to COVID-19, including through the advancement of research and policy analysis to meet women's needs. To advance results on the Sustainable Development Goals, Ms. Hendriks spearheaded the agency's efforts as convener of the Generation Equality Forum Action Coalitions, a leading global multi-stakeholder initiative to accelerate investment and implementation on gender equality.

Prior to joining UN Women, Ms. Hendriks served as the Director, Gender Equality, Global Growth and Opportunity at the Bill & Melinda Gates Foundation (2015–2019), developing the Foundation's first-ever strategy on gender equality and women's economic empowerment, driving new global philanthropic investment of USD 170 million. This work was supported by Ms. Hendriks' leadership to design and launch a global investment strategy on gender data, catalysing a USD 80 million portfolio and institutional support on gender data as core to advancing global accountability to the 2030 Agenda for Sustainable Development.

A national of Canada, Ms. Hendriks holds an M.A. in Adult Education and International Development from the University of Toronto and B.A. in International Justice and Human Rights from McMaster University, Canada.

H.E. Mr. Antonio Manuel Revilla Lagdameo, Permanent Representative of the Philippines to the United Nations and Chair of the Commission on the Status of Women (CSW) at its 68th session

Prior to his appointment, His Excellency Antonio Lagdameo served the Philippines' Ambassador to the United Kingdom, from 2016 to 2022 and from 2009 to 2010. From 2008 to 2009, he was Ambassador to Spain and the Principality of Andorra. From 2007 to 2008, he also served as Ambassador to Mexico, with concurrent accreditation to Belize, Costa Rica, El Salvador, Guatemala, Honduras, Nicaragua and Panama. In other governmental positions, he was Chairman of the Philippine Racing Commission from 1994 to 1998. His private office and civic affiliations include Chairman of the Board, Carrije Holdings, beginning in 2000 and Vice Chairman for House of Travel Inc.

He received his Associate degree from the University of the Philippines in 1961, his Bachelor of Arts in accounting from the University of the East in the Philippines in 1964 and his graduate degree from the Ateneo de Manila University, Philippines in 1971.



#### Ms. Geraldine Fraser-Moleketi, Chancellor of Nelson Mandela University and Chair of the Committee of Experts on Public Administration (CEPA) at its 23rd session

Geraldine Joslyn Fraser-Moleketi is the former Special Envoy on Gender at the African Development Bank. In this role, she led a strategy to mainstream gender in the Bank's policies and operations, making the Bank a reference institution on gender equality in Africa. She was previously Director of the Democratic Governance Group of the United Nations Development Programme, with activities in more than 170 countries, supported from six

regional service centres. She served in the South African Government as Minister of Public Service and Administration for two consecutive terms. As Minister, she led the development of a senior management service within the South African public service; oversaw a comprehensive review of the public service remuneration system; revitalized the "Batho Pele" strategy within the public service; and established the Government Employees Medical Scheme and Public Administration Leadership and Management Academy. She also served as Chair of the Pan African Ministers of Public Service for three consecutive terms and has worked on intergovernmental bodies globally and in Africa. While Minister for Public Service and Administration, she served as a member of the United Nations Committee of Experts on Public Administration. As Minister for Welfare and Population Development in the first democratic Government of South Africa, she introduced the Government's white papers on social welfare (1997) and on population policy (1998) in the Parliament, worked on the development and implementation of the Child Support Grant and chaired the Ministerial Team on Children and Youth at Risk. She served as Deputy Minister of Welfare and coordinated the country's preparations for the Fourth World Conference on Women, held in Beijing in 1995.

Mr. Achim Steiner, Administrator, United Nations Development Programme (UNDP)

Mr. Achim Steiner first was appointed as UNDP Administrator on 19 June 2017. Following the recommendation of the Secretary-General, after consultation with Member States, the General Assembly confirmed Achim Steiner of Germany as Administrator of the United Nations Development Programme (UNDP) for a further four-year term of office beginning on 17 June 2021. Mr. Steiner is also the Vice-Chair of the UN Sustainable Development Group, which unites 40 entities of the UN system that work to support sustainable development. Over nearly three decades, Achim Steiner has been a global leader on sustainable development, climate resilience and international cooperation. He has worked tirelessly to champion sustainability, economic

growth and equality for the vulnerable, and has been a vocal advocate for the Sustainable Development Goals.

Prior to joining UNDP, he was Director of the Oxford Martin School and Professorial Fellow of Balliol College, University of Oxford. Mr. Steiner has served across the United Nations system, looking at global challenges from both a humanitarian and a development perspective. He led the United Nations Environment Programme (2006-2016), helping governments invest in clean technologies and renewable energy. He was also Director-General of the United Nations Office at Nairobi. Achim Steiner previously held other notable positions including Director General of the International Union for the Conservation of Nature, and Secretary General of the World Commission on Dams. Achim Steiner has lived and worked in Africa, Asia, the Middle East, Europe, Latin America and the United States. He graduated in Philosophy, Politics and Economics (MA) from Worcester College, Oxford University and holds an MA from the University of London/School of Oriental and African Studies (SOAS).



#### Mr. Claver Gatete, Executive Secretary, Economic Commission for Africa (ECA)

Mr. Gatete is currently Ambassador and Permanent Representative of the Republic of Rwanda to the United Nations in New York. A seasoned economist, he brings to the position extensive strategic leadership expertise, coupled with international experience in the political and financial landscape of the African continent. # Ms. Celeste Saulo, Secretary-General, World Meteorological Organization (WMO)

Ms. Saulo took office as the Secretary-General of the World Meteorological Organization (WMO) in January 2024, the first female and first South American to head the WMO.

Prior to this, she served as the Director of the National Meteorological Service of Argentina since 2014 and was the First Vice-President of the WMO. She was elected to the WMO Executive Council in June 2015. She has been a member of the WMO World Weather Research Programme

(WWRP) Scientific Steering Committee since 2011 and has served on various WMO panels related to her



field of knowledge. She is full professor at the University of Buenos Aires and research scientist at the National Council for Scientific and Technical Research. As the Director of the Argentinean National Meteorological Service, she has given rise to interinstitutional and interdisciplinary effort and dedication to contribute to the commitments made by the country with regards to the 2030 Agenda for Sustainable Development and the Sendai Framework. Under her direction, the Argentinean National Meteorological Services of developing countries, with a specific focus on training in accordance with the country's role of Regional Training Centre and the inclusion and integration of the younger generations of scientists, leading to the creation of the WMO YESS (Young Earth System Scientists) Office.

Ms. Saulo launched her academic career as a teaching assistant in Atmospheric Sciences at the University of Buenos Aires (UBA), where she earned an undergraduate degree in 1987 and a PhD in 1996. Her peers, students and graduates, elected her as Director of the Department of Atmosphere and Ocean Sciences at the Faculty of Exact and Natural Sciences of the UBA for two consecutive periods (2009-2013). Her extensive teaching experience is in the areas of numerical weather prediction, atmosphere dynamics and thermodynamics, mesoscale meteorology, cloud dynamics and cloud microphysics. She has authored and co-authored 46 peer-reviewed scientific journal articles and book chapters. Furthermore, she has supervised five doctoral theses as well as many students, both at the undergraduate and graduate levels, acting as principal investigator or co-principal investigator on research projects funded by international and national agencies.



## Mr. Robert Powell, Director of New York Office, International Monetary Fund (IMF)

Robert Powell is the International Monetary Fund's Special Representative to the United Nations. His extensive experience at the IMF includes policy development, aid effectiveness, country operations, debt relief activities, and capacity building.
