OPENING REMARKS

I am pleased to join you at the opening of the **2024 Coordination Segment** of the Economic and Social Council. May I extend a warm welcome to the Chairs of functional commissions and expert bodies of the Council, Executive Secretaries of regional commissions, and Heads of UN system entities joining us today.

This year, the **Coordination Segment** will focus thematically on "Reinforcing the 2030 Agenda for Sustainable Development and eradicating poverty in times of multiple crises: The effective delivery of sustainable, resilient, and innovative solutions", the main theme of the 2024 session of the Council.

The Partnership Forum, which took place yesterday, also focused on this theme, holding discussions to advance sustainable development through inclusive, multistakeholder dialogues. The multi-stakeholder participatory forum demonstrates our

I am therefore delighted to share here with you the key messages from the Partnership Forum.

Excellencies,

The <u>2024 ECOSOC Partnership Forum</u> emphasized the pivotal role that **effective partnerships** play in the pursuit of sustainable development. These partnerships serve as a **crucial mechanism for pooling resources and expertise**, ensuring our efforts translate into tangible impacts on the ground.

Throughout the discussions, it was widely recognized that the success of partnerships hinges on **respecting country ownership and local context** while upholding **stringent accountability measures**. The comprehensive nature of multistakeholder partnerships was underscored, transcending sectors, institutions, and geographical borders to tackle the interconnected challenges we face.

Member states shared a **heightened sense of urgency** demanding our immediate attention and concerted efforts, leaving no one behind, especially those grappling with the depths of poverty and with weakest capacities. Participants collectively advocated for more open, inclusive engagements, emphasizing the need to focus on vulnerable groups and mobilize resources to overcome various capacity barriers.

The forum has yielded tangible proposals, including initiatives and alliances that will significantly influence the forthcoming discussions at the High-level political forum on sustainable development in July, and subsequently the Summit of the Future in September.
