# **BACKGROUND & KEY ISSUES**

According to the 2024 Sustainable Development in the UNECE Region report, those at the highest risk of experiencing poverty are still struggling to access social protections, especially in the realms of access to sanitation services, financial and food security, safety, and justice. The report shows that, while the region is on track in achieving certain indicators, **there are still social protection gaps to be filled in order to achieve targets related to SDGs 1, 2, 13, 16, and 17 by 2030**.<sup>1</sup>

It is estimated that approximately 45 million young children across the globe suffer from severe malnutrition each year,<sup>2</sup> and that 90 percent of children worldwide feel the burden of diseases attributable to climate change.<sup>3</sup> The interlinked effects of global conflicts, climate change, food systems and ecosystems degradation, and extreme poverty are most felt by children and youth—and in particular young women and girls—leaving the most affected in an inescapable cycle of vulnerability. Coupled with the lack of tangible local implementation of the SDGs, the further decay of social protection systems as a direct result of the climate crisis and increased conflicts around the world, is posing direct and undeniable threats to the sustainability of current and future generations.

Inter- and cross- generational solidarity is needed in all spaces now more than ever before—and particularly approaching the High Level Political Forum and Summit of the Future—to ensure the meaningful implementation of the SDGs locally, nationally, and globally. Meaningful youth engagement, as outlined in the Secretary General's

"Our Common Agenda",<sup>4</sup> must be driven first and foremost by inter-generational, inter-community, and interstakeholder solidarity.

In the 2024 Youth Report for the UNECE Regional Forum on Sustainable Development on the SDGs under Review, **youth from the ECE region drafted recommendations to advance human rights-based sustainable development**. In solidarity with the most marginalized and most affected by global environmental and conflict catastrophes, the youth see the SDGs under review (1, 2, 13, 16, and 17) as deeply interconnected and needing immediate action. They stress the pivotal role of education, youth participation and financial distribution to the most vulnerable and marginalized communities to achieve SDG1; They highlight the inequities in our food systems that hinder progress to achieve SDG2 and urge for the end of food waste and the importance that food supplies reach areas affected by conflict without restriction; They demand bold action to progress on SDG13, including a phase-out of fossil fuels, and the inclusion of youth in the climate space, such as the Early Warnings for All Initiative, NDC assessments and VNRs developments; The youth of the region urge to stop all ongoing devastating conflicts and wars and to uphold the fundamental freedoms of speech and peaceful protest, necessary to achieve SDG16 and all the Goals, and propose to establish Youth Well-Being Index to facilitate evidence-based relevant youth policy; Aligned with SDG17, they recognize the key role of multi-stakeholder dialogue and partnerships to achieve the SDGs, which need inclusive and disaggregated data, transparency, and inclusive social dialogue.

As we approach the High-Level Political Forum and the Summit of the Future, inter- and cross-generational solidarity becomes imperative to ensure meaningful implementation of the SDGs, as echoed in the recommendations drafted by youth from the ECE region. Giving youth a seat at the table through inclusive dialogue and partnerships is fundamental to ensure that intergenerational approaches are guiding the Pact of the Future and the Declaration on Future Generations.

#### **OBJECTIVES OF SESSION/PLENARY**

- 1. Reflecting on the outcomes of the Regional Youth Assembly and the Regional Forum on Sustainable Development (RFSD) and how they inform **tangible action to achieve SDGs 1, 2, 13, 16, and 17** in the lead up to the High Level Political Forum and the Summit of the Future.
- Building on the ECE Regional Youth Report with recommendations on each of the SDGs under review as a direct result of the Regional Youth Assembly, follow up on the regional consultations and give young people in the ECE region a platform in the UN headquarters in New York to further share their experiences, expertise, priorities, recommendations, and demands regarding the SDGs under review in the upcoming HLPF and SoTF processes.
- 3. Showcasing successful examples of **best practices of meaningful youth inclusion and engagement** in decisionmaking.
- 4. Providing an **interactive platform between youth and Member States** to exchange priorities and inputs for the negotiations of the Pact for the Future.

## **OVERVIEW OF PREPARATORY EVENT/CONSULTATION**

This session builds on the **Regional Youth Assembly in the lead-up to the Regional Forum on Sustainable Development (RFSD).** Over a hundred adolescents and youth gathered virtually on March 7<sup>th</sup> and 8<sup>th</sup>, and around thirty individuals convened in-person in Geneva on March 12<sup>th</sup> as the Pre-Meeting to RFSD, to frame their priorities and demands - as well as showcasing how young people across the region are leading action on the SDGs. The Youth Assembly provided a dynamic platform for policy discussions, training and capacity building for youth engaging at the RFSD. In particular, the youth assembly reflected on the themes of the RFSD, with a focus on the SDGs under review, specifically progress in the areas of SDG 1 (no poverty); SDG 2 (zero hunger); SDG 13 (climate action); SDG 16 (peace, justice and strong institutions); and SDG 17 (partnership for the Goals).
