## BACKGROUND & KEY ISSUES

The 75th anniversary of the UN in 2020 came amid the world confronting the shared threats of the COVID-19 and climate change, risks and opportunities of technological advances, and stagnation on the SDGs. In recognition of these challenges and their interconnectedness, Member States <u>asked the Secretary-General</u> to prepare recommendations. The Secretary-General published <u>Our Common Agenda</u>, calling for solidarity and renewal of the multilateral system to accelerate implementation of existing commitments and fill gaps in global governance since 2015. The report proposed a *Summit of the Future* as a once-in-a-generation opportunity to take these steps. UNGA decide for the Summit to happen in **September 2024**, building on the 2023 SDG Summit, with an intergovernmental outcome **Pact for the Future**, comprising five chapters on i) sustainable development and financing for development; ii) international peace and security; iii) science, technology and innovation and digital cooperation; iv) youth and future generations; and v) transforming global governance. The negotiations for the Pact are already taking place with different iterations of Pact being made available.

Young people today make up one quarter of the total global population with 87% living in developing countries.<sup>1</sup> Whilst youth are often at the forefronts of impacts of planetary crisis, through their intellectual contributions, ability to mobilize support, lead campaigns, empower communities and take action on the ground, they have been leading transformative changes globally. Youth are disproportionately affected by the global financial architecture, as it shapes employment opportunities, access to education, health services and social mobility, leading them to experience a 23% employment loss due to the COVID-19 pandemic, compared to a 13% loss among adults older

than 25.<sup>2</sup> Additionally, the burden of national and personal debt, alongside limited access to financial resources restricts the ability of youth-led organizations to innovate or even operate in many cases. The New Agenda for Peace must be an agenda supporting young people. In 2019, it was estimated that nearly 408 million young people lived in areas affected by armed conflict, which has only increased within the past year.<sup>3</sup> Despite this, young people remain underrepresented in decision-making forums, limiting their ability to contribute to peace and security solutions. The digital divide, characterized by unequal access to and proficiency in digital technologies, poses a significant challenge to achieving SDGs worldwide. Bridging this gap is essential for promoting inclusive economic growth, improving access to education and healthcare, and fostering innovation and entrepreneurship in the digital age.

Young people's participation and leadership in the lead up to the Summit of the Future and in the Pact for the Future is critical, and must be translated into a consultative process before, during and after the Summit of the Future, with special focus on mainstreaming youth voices global south, SIDS and other marginalized communities. To that purpose, on the third day of the ECOSOC Youth Forum, the plenary session "INSIGHTS & RECOMMENDATIONS: THE VOICES OF YOUTH TO THE SUMMIT OF THE FUTURE", will offer a platform for a multi-stakeholder dialogue and consultation. The moderated conversation and outcomes of the session will serve as a key input to the upcoming High-Level Political Forum and Summit of the Future

Young people have been organizing their participation and inputs for the Summit of the Future since 2022 (access roadmap here) across various UN fora. The Youth Working/Focus of Summit of the Future, launched by MGCY in 2022, provides direct inputs to the process. The first version of the global youth policy paper for the Summit was published in January 2024 and the inputs to the zero draft published in February 2024. Young people and youth organizations also actively engaged during the various consultations hosted by the co-facilitators of the negotiation process.

Therefore, building on these processes and existing groundwork, this session will allow to collect and further mainstream youth voices and feedback on the Pact for the Future, and its associated documents - Declaration on the Future Generations and the Global Digital Compact, and young people's contributions to the 2030 Agenda and vision for the future. It will feature high-level officials, and a diversity of young people, Member states representatives, civil society, and other young development practitioners.

## **OBJECTIVES OF SESSION/PLENARY**

- To convene diverse youth constituencies and partners in lead up to HLPF and Summit of the Future, building upon existing and ongoing youth consultations on SDGs, Pact for the Future, Declaration on Future Generations and Global Digital Compact
- To amplify and consolidate young people's voices and collect their feedback, including from marginalized and underrepresented youth communities in a safe and meaningful space.
- To feed into the ECOSOC Youth Forum informal summary and Presidential statement, and the "Voices of Youth" Report by youth constituencies
- To highlight on-ground solutions by youth-led organizations and partners in advocating and taking action for their future, as good practices for the Pact's implementation
