United Nations Institute for Training and Research (UNITAR)

UNITAR is the principal training arm of the UN system headquartered in Geneva with Offices in New York, Hiroshima and Port Harcourt. The office has been developing trainings for 2nd Committee delegates related to the operation activities of development in 2012, 2016, 2020 and is in the process of 2024 preparation. UNITAR operates with a vision of providing knowledge “on the UN, by the UN and for the UN”. It develops and delivers an average of 30 courses annually to thousands of members of the international community – diplomats, UN staff, the members of civil society (including NGOs) and the private sector. Its courses focus on: 1) developing technical knowledge of the UN system and its functioning; 2) building skills that are specific to multilateral diplomacy; and 3) exchanging information and research in the form of Conferences (or series of Conferences) on areas of topical and immediate interest to negotiators at the UN. QCPR is a successful collaboration between the Permanent Mission of Switzerland to the UN, United Nations Institute for Training and Research (UNITAR), and the United Nations Department of Economic and Social Affairs (UN DESA).



United Nations Department of Economic and Social Affairs (UN DESA)

UN DESA is a vital interface between global policies and national action in the economic, social and environmental spheres. Guided by the universal and transformative 2030 Agenda for Sustainable Development and other global agreements, UN DESA responds to the needs and priorities of the global community, whether by organizing major UN conferences, supporting intergovernmental bodies, taking the pulse of the latest socioeconomic trends, publishing cutting-edge analyses or helping countries develop capacity. DESA provides the trusted data that governments use to make decisions about the future, brings the global community together to find common solutions to the world’s most pressing problems and helps countries translate their global commitments into national action in the economic, social and environmental spheres.

Quadrennial Comprehensive Policy Review (QCPR)

Background

- The quadrennial comprehensive policy review (QCPR) is the mechanism through which the General Assembly assesses the effectiveness, efficiency, coherence, and impact of the United operational activities for development, and it establishes system-wide policy orientations for operational activities for development and country-level modalities of the UN.
- The most recent review took place in 2020 and culminated in the adoption of the landmark General Assembly resolution on the QCPR of operational activities in the United Nations development system (75/233).

Expected Outcome

- Through enhanced QCPR literacy and engagement, the training series aims to strengthen informed participation of Second Committee delegates, Economic and Social Council (ECOSOC) delegates, ahead of the deliberations on the General Assembly Resolution negotiation for the 2024 QCPR.
- The series undertakes an overview of the guidance provided and update on the QCPR and UNDS repositioning, specifically addressing the areas where accelerated action is needed, and path forward to the 2024 QCPR and beyond.

Planned Output

- Up to 60 delegates of New York Permanent Missions trained (hybrid) on the QCPR
- Updated substantive information and knowledge on QCPR and UNDS repositioning.
- This course is open for the in-person and remote participation of Permanent Missions accredited to the UN Headquarters and other government officials; representatives of international, intergovernmental, and non-governmental organizations, and other interested individuals. Priority is given to delegates from developing and least developed countries.

Quadrennial Comprehensive Policy Review (QCPR)

Module 1: Navigating the Future: Context and priorities for the QCPR

This training module will introduce the Quadrennial Comprehensive Policy Review (QCPR) of operational activities for development of the United Nations system (UNDS), including the enhanced role of the resident coordinator system and other elements of the recently concluded repositioning exercise. It will provide the context for the QCPR and give an overview of the changes made by the UN development system in the last QCPR cycle. The module will also discuss priority areas for the 2024 QCPR and how the UN system is scaling up support for SDG acceleration, including through the implementation of the 2023 SDG Summit Political Declaration, focusing on six key transition areas: (1) food systems transformation; (2) energy transitions and access; (3) digital connectivity; (4) education and skills gaps; (5) decent jobs and social protection including healthcare; and (6) triple planetary crisis: climate change, biodiversity loss and pollution.

Module 2: Scaling up UNDS support for countries to achieve the SDGs

In the light of significant global changes since the current QCPR resolution was adopted in 2020, this module will examine the areas in need of continued focus to ensure full implementation of the repositioned UN development system and the revitalized Resident Coordinator system. This module will focus on the implementation of the reform measures in practice and examine the essential steps needed to accelerate progress towards achieving the SDGs. The first panel will center on harnessing the support of the UN development system across global, regional, and country levels to facilitate key transitions while ensuring that no one is left behind. The second panel will focus on progress and challenges in UN country team configurations and the reform of business operations to maximize the impact of the UN system.

Module 3: Funding UN operational activities for development and Financing the SDGs

This module will delve into critical aspects of the funding for UN operational activities for development and financing the achievement of the Sustainable Development Goals (SDGs). The scene is set by outlining the insights and outcomes provided during this 2024 ECOSOC operational activities for development segment (OAS) and its implications for the 2024 QCPR. The module will present an overview of system-wide funding trends and the renewed Funding Compact. This conversation will deepen participants' technical understanding of the structures of different funds, as well as conditions around the funding. Additionally, participants will discuss how collaboration with International Financial Institutions (IFIs) and multilateral development banks (MDBs) can be further leveraged to bolster financing and coordinate activities in support of SDG acceleration. Looking ahead to 2028, participants will explore what is needed to finance significant SDG acceleration and ensure sustainable funding patterns.

Module 4: Looking forward to the 2024 QCPR

The final module of the UNITAR QCPR training series for delegates provides an overview of key highlights from previous modules and outlines the pathway to the 2024 QCPR. In this context, it will present a concise overview of the key outcomes of the recent Summit of the Future, the 2024 Financing for Development Forum (FFD) and the High-Level Political Forum on Sustainable Development (HLPF), elucidating the implications for the 2024 QCPR. Moreover, this module will delve into the lessons learned from the 2020 QCPR negotiations, drawing upon the experiences from the 2020 QCPR negotiation process. Additionally, Assistant Secretary-General and Director of the Development Coordination Office will share valuable perspectives derived from the implementation of the QCPR 2020, along with recommendations aimed at strengthening the system in the future. Finally, there will be an update provided by the drafters of the 2024 QCPR on the status of preparation.
