



## Informal consultation on QCPR status reporting

### Background Note for Informal consultation with Member States, 7 February 2024

The Secretariat will hold an informal consultation with Member States on QCPR status reporting, on 7 February 2024, at 10.00 a.m. in the ECOSOC Chamber.

#### 1. Background

In 2024, the General Assembly will conduct the next quadrennial comprehensive policy review (QCPR) of the United Nations operational activities for development. In preparation for the QCPR negotiations, the General Assembly, in resolution 78/166, requested the Secretary-General to hold open and inclusive informal consultations with Member States on status reporting on the implementation of the current 2020 QCPR<sup>1</sup>, building on an earlier request by the Economic and Social Council (ECOSOC).<sup>2</sup>

**QCPR status reporting:** In preparation for the 2024 QCPR, status updates of QCPR implementation will cover all provisions and mandates in General Assembly resolution 75/233, including integrating and mainstreaming provisions and mandates, such as those outlined in the QCPR monitoring and reporting framework<sup>3</sup> and those on the acceleration of the 2030 Agenda and its Sustainable Development Goals.

Current reporting on the QCPR: Member States currently receive, as official documentation to the ECOSOC, annual reports by the Secretary-General on the implementation of the QCPR, and by the UN Sustainable Development Group's Chair on the Development Coordination Office and the Resident Coordinator system.<sup>4</sup> The Secretary-General's report is also submitted to the General Assembly. These two detailed reports contain evidence-based assessments of status, results, performance and recommendations on QCPR implementation. A variety of detailed additional documents including addenda, annexes and data is also made available to help oversee and monitor the QCPR implementation (see Annex for a detailed listing).

The Secretariat will hold an informal consultation with Member States on QCPR status reporting on 6 February 2024. Additional informal consultations can be organized as needed. These would be an opportunity for Member States to discuss the information available related to QCPR implementation and guide the Secretariat on priority areas on QCPR status reporting that could be considered within existing resources as a way to best inform Member States in crafting of the 2024 QCPR for its guidance to the UN development system.

Status reporting would aim to complement and not substitute the substantial amount of information and evidence already available to Member States on each QCPR mandate.

Status updates could be provided in different formats including informal briefings, notes and case studies. Updates could also be provided in the context of the planned QCPR Delegate training series to be organized by the Secretariat in 2024, ahead of the start of QCPR negotiations.

**Outcome:** Following the consultation, the Secretariat will provide a summary of the consultation and incorporate information and guidance into its reporting and capacity building towards QCPR 2024.
