### **3. Dialogue with UNDS Executive Heads: Unlocking transformations through integrated policy support at global, regional, and country levels**

**Objective:** *UNSDG Executive Heads will engage in a conversation on the orientation of the UN development system (UNDS) to increase delivery of integrated policy support for the SDGs, including delivery by entities not present in programme countries. Executive Heads will provide their insights on the progress made in implementing the 2020 quadrennial comprehensive policy review. This segment will help provide a stock taking opportunity on how the reforms have been implemented thus far, whilst identifying areas where more momentum may be required. High-level representatives from Member States are invited to engage in a dialogue with Executive Heads, focused on the respective priorities and constraints faced by both governments and the UN entities alike, with a view to discussing areas of common focus for improvement.*

### ***8. Means of implementation: financing the SDGs: Development financing priorities that can have a catalyzing effect to achieve system-wide results in the 2030 Agenda implementation***
