Submission of two written contributions to the 2024 High-Level Political Forum



Invitation to all Member States and all relevant stakeholders to provide views on how the Commission can contribute to the 2030 Agenda, especially SDG 16, with the outcome submitted to the HLPF (CRP.5) (RES/A/78/225)

Policy and awareness-raising initiatives at the global level on accelerating the implementation of the Sustainable Development Goals, including Goal 16, through, namely, social media campaign (RES/A/78/225)

Encouragement of Member States to consider including information related to the work of the Commission, including on the implementation of SDG 16, in their VNRs for 2024, and report on it during the 33rd regular session (RES/A/78/225)

“We undertake to intensify our efforts to prevent and counter crime and make criminal justice systems more effective, humane, transparent and accountable.”

How the Commission followed up on the 2022 review of the work of the functional commissions and expert bodies

Based on an analysis of the Summary of Recommendations by ECOSOC in 2022, the CCPCJ focused on **enhancing implementation of recommendations with more scope for action**, including:

✓ Strengthen cooperation with other functional commissions

Example: organized joint side events, invitation to thematic discussions & to regular sessions.

✓ Make recommendations to advance 2030 Agenda & SDG links

Example: adoption A/RES/78/225, invited Member States to submit recommendations on 2030 Agenda implementation; to include SDG 16 in their VNRs for 2024 and report on VNR results at 33rd regular session in 2024

✓ Climate change & issues within purview of commissions

Example: side-event at the COP28 in Dubai in December 2023, supporting awareness-raising events on Protecting People and the Planet in preparation for the 15th Crime Congress in 2026

✓ Youth engagement in intergovernmental processes

Example: launched GenJust initiative on increasing youth engagement at the 15th Crime Congress
