It is through this collaboration that we can turn the tide on SDG delivery and uphold the promise of a better world for all.

In 2025, ECOSOC will advance its work under the annual theme of "Advancing sustainable, inclusive, science- and evidence-based solutions for the 2030 Agenda for Sustainable Development and its Sustainable Development Goals for leaving no one behind".

A set of SDGs on health, gender, decent work and economic growth, oceans and seas, as well as partnerships will be reviewed in-depth at the High-level Political Forum on Sustainable Development (HLPF) in July, where 39 countries will also present their voluntary national reviews on their implementation of the 2030 Agenda.

The Council will also seek to contribute to other key UN processes in 2025, such as the Fourth International Conference on Financing for Development, the Third UN Ocean Conference, the Second World Summit for Social Development, to ensure a holistic and integrated approach to advancing the SDGs.

Dear colleagues,

The Pact for the Future adopted last September calls for the strengthening of ECOSOC to accelerate sustainable development.

It is our collective responsibility to fully utilize ECOSOC's potential and ensure that it can effectively deliver its Charter mandates.

We must empower the Council to provide robust, evidence-based, innovative, and actionable policy guidance to effectively address the crises that are hindering the SDGs.

We should also make full use of the Council to deepen its engagement with international financial institutions to help bridge the significant financing divide and address gaps in financing for development, particularly for fragile and conflict-affected countries.

To leave no one behind, it is crucial for the Council to address the crisis of displacement, promote better-managed migration systems, and safeguard the rights of tens of millions of people on the move.

Artificial Intelligence needs to be on the Council's agenda, building on the Global Digital Compact, with special focus on bridging the digital divide and ensuring equal and ethical access to this transformative technology to shape a safe and sustainable digital future for all.

These are key priorities of the present ECOSOC presidency, which will be highlighted through a series of special meetings of the Council this year.

Additionally, gender equality, the active participation of civil society, and the representation of diverse voices, including youth, need to be reflected across all ECOSOC segments and forums.
