H.E. Mr. Anatolio Ndong Mba (Equatorial Guinea), Vice-President of the Economic and Social Council responsible for the Coordination Segment

Anatolio Ndong Mba was appointed Ambassador to the United Nations on January 7, 2010.

Prior to his appointment, Mr. Ndong Mba was a consultant with the Food and Agriculture Organization (FAO), serving as the agency's

representative in Djibouti from November 2008 to February 2009. Between 2004 and 2008, he served as FAO representative in Angola and Sao Tome and Principe, resident in Luanda. He also served as Acting United Nations Resident Coordinator from March 2007 to July 2008, when he retired from the agency. From 2001 to 2004, Ndong Mba was Deputy Regional Representative of FAO for Africa and Representative in Ghana. He having served as Representative in Guinea-Bissau between 1997 and 2001.

Ndong Mba's extensive ministerial experience included terms as Minister of State for Fisheries and Forestry (1996-1997); Deputy Prime Minister and Minister for Finance and Equatorial Guinea Governor at the International Monetary Fund (1994-1996); Minister of State for Planning and International Cooperation and Equatorial Guinea Governor to the World Bank (1992-1994); and Minister for Agriculture, Livestock, Fisheries and Forestry (1989-1992).

He was Secretary-General in the Ministry of Agriculture and Rural Development (1986-1989); Chief of Staff of the Planning, Research and Monitoring Project in the Ministry of Agriculture, Livestock, Fisheries and Forestry (1984-1986); Secretary-General in the same Ministry (1982-1984); and Director General of Livestock (1981-1982).

Ndong Mba holds a Bachelor of Science in agro-livestock from Zagazig University in Egypt, as well as diplomas in animal production and rural credit.

He was born in Equatorial Guinea on July 3, 1946, is married and the father of a large family.







H.E. Mr. Bob Rae, Ambassador and Permanent Representative of Canada to the United Nations and President of the Economic and Social Council

Bob Rae is the Ambassador and Permanent Representative of Canada to the United Nations in New York. He has served in this post since August 4, 2020. Since assuming this role has been active in all aspects of the work of the UN, culminating in his election to the Presidency of the Economic and Social Council (ECOSOC) for 2024-25, the second Canadian to assume this role, and joins Lester Pearson (President of the General Assembly 1952-53) and George Davidson (ECOSOC 1958-59) as Canadians elected in

their personal capacity to preside over UN Charter bodies.

Mr. Rae served as Premier of Ontario from 1990 to 1995, and interim Leader of the Liberal Party of Canada from 2011 to 2013. He was elected to federal and provincial parliaments eleven times between 1978 and 2013. He has been honoured by the alumni of both bodies for his distinguished service.

Mr. Rae received his Honours B.A. in Modern History from the University of Toronto, an M.Phil in Politics as a Rhodes Scholar at Balliol College in Oxford University, and graduated from the University of Toronto Faculty of Law in 1977. He was a Lecturer in the Faculty of Business (1976-77) and also served as assistant to the Canadian General Counsel of the United Steelworkers from 1975 to 1977. He was called to the Bar of Ontario in February in 1980 and was named a Queen's Counsel in 1984.

Mr. Rae has worked with three law firms, Sack Charney Goldblatt and Mitchell (1977 to 1982), Goodmans LLP (1996 to 2007), and Olthuis Kleer Townshend LLP (2014 to 2020), each drawing on his skills as a scholar, an advocate, a mentor and a mediator. Among other notable assignments, Mr. Rae led the restructuring of the Canadian Red Cross, the Toronto Symphony Orchestra, and chaired the board of the Royal Conservatory of Music. He also wrote "Lessons to be Learned" on the Air India bombing, and "Ontario a Leader in Learning" - a study of the Ontario higher education system. He was also named to the Security and Intelligence Review Committee by then Prime Minister Chrétien. He served as the Chief Negotiator for the nine First Nations that are members of the Matawa Tribal Council in Northern Ontario between 2013 and 2018.

Mr. Rae's return to Parliament for the constituency of Toronto Centre in 2008 led to his appointment as Foreign Affairs spokesman for his party, and to his election as interim Leader in 2011. From 1996 to 1999 and between 2013 and 2020, he taught law, politics, public policy at the University of Toronto, and was a partner and senior counsel to the law firm OKT LLP, specializing in indigenous law and constitutional issues. Mr. Rae is a Fellow of the Forum of Federations (an organization he co-founded in the 1990's), Massey College, the Raoul Wallenberg Centre for Human Rights, and the Munk School of Global Affairs and Public Policy.

In October 2017, Mr. Rae was appointed as Canada's Special Envoy to Myanmar. In this role, he engaged in diplomatic efforts to address the crisis in the country's Rakhine State and wrote the report "Tell Them We're Human" in 2018. In March 2020, he was named by Prime Minister Trudeau to be Canada's Special Envoy on Humanitarian and Refugee Issues. This led to his report "A Global Pandemic Requires a Global Response", which was made public shortly before his appointment as Ambassador to the UN.







Mr. Rae is a Privy Councillor, a Companion of the Order of Canada, a member of the Order of Ontario, and has numerous awards and honorary degrees from institutions in Canada and around the world. In addition to several government reports, he is the author of six books, "From Protest to Power", "The Three Questions", "Exporting Democracy", "Canada In The Balance", "What's Happened to Politics", and "Reflections on a public life (The Symons Lecture").



Mr. Guy Ryder, United Nations Under-Secretary-General for Policy

United Nations Secretary-General António Guterres announced on 7 October 2022 the appointment of Guy Ryder of the United Kingdom as Under-Secretary-General for Policy in his Executive Office.

Mr. Ryder was most recently Director-General of the International Labour Organization (ILO) in Geneva after serving two successive terms since October 2012. He first joined the ILO in 1998 as Director of the Bureau for Workers' Activities and from 1999, served as Director of the Office of the Director-General.

Mr. Ryder started his professional career in 1981 as an assistant at the International Department of the Trades Union Congress in London. From 1985, he held the position of Secretary of the Industry Trade Section of the International Federation of Commercial, Clerical, Professional and Technical Employees (FIET) in Geneva. In 1988, he became Assistant Director and – from 1993 - Director of the Geneva office of the International Confederation of Free Trade Unions (ICFTU). In 2002, he was appointed General Secretary of the ICFTU and was elected as the first General Secretary of the International Trade Union Confederation (ITUC) when it was created in 2006. He returned to the ILO in 2010 as Executive Director, responsible for international labour standards and fundamental principles and rights at work.

Mr. Ryder studied Social and Political Sciences at the University of Cambridge and Latin American Studies at the University of Liverpool. He speaks English, French and Spanish.



Ms. Minh-Thu Pham, Co-founder of Project Starling, Nonresident Scholar at the Carnegie Endowment for International Peace, and Lecturer at the School of Public and International Affairs, Princeton University

Minh-Thu Pham is a nonresident scholar in the Global Order and Institutions Program at the Carnegie Endowment for International Peace.

Her primary areas of interest are multilateral cooperation and summit diplomacy, international organizations, sustainable development, and global governance and democracy. She also runs Project Starling, a group that works on renewing institutions, and teaches at the Princeton School of Public and International Affairs and Bard Globalization and International Affairs program. Minh-Thu was an advisor to UN Secretary-General Kofi Annan, where she helped to steer the UN through a period of deep crisis after the Iraq War and played a key role in the 2005 World Summit.





As executive director of global policy at the UN Foundation, she started and ran a global effort to help the UN create and deliver the Sustainable Development Goals and undertake institutional reforms. Minh-Thu has led dozens of track 1.5 and 2 dialogues with ambassadors and civil society actors that have resulted in political breakthroughs. She built a global network of stakeholders to shape summit negotiations, which included think tanks and civil society actors from Africa, Asia, and Latin America. Her work helped to open up UN decision-making processes to a broader constituency. More recently, Minh-Thu has advised efforts to strengthen democracy globally and in the United States, and led an effort to mobilize immigrant voters and tackle misinformation.

Minh-Thu has been featured in the *Washington Post*, the *New York Times, Politico, NBC Nightly News*, the *Tavis Smiley Show*, and Cheddar TV among others. She serves on the boards of several nonprofits and is a fellow of the Truman National Security Project, a member of the Leadership Now Project, and was a term member of the Council on Foreign Relations (2007-2012). She came to the U.S. as a refugee from Vietnam and currently lives in New York City.



Mr. CLAVER GATETE - Under Secretary-General and Executive Secretary of the United Nations Economic Commission for Africa (ECA)

Claver Gatete is the tenth Under Secretary-General and Executive Secretary of the United Nations Economic Commission for Africa, appointed in October 2023.

Prior to this, he served as Ambassador of Rwanda to the United Nations. He has also served as Minister of Infrastructure, Minister of Finance and Economic Planning, and Governor of the National Bank of Rwanda. He also served as Ambassador of Rwanda to United Kingdom, Ireland, and Iceland.

Mr. Gatete is a seasoned diplomat and economist with acclaimed recognition on Africa's development issues. He was awarded Finance Minister of the Year in

2015 and 2016 at the African Bankers Awards and by Global Capital respectively. He has held various roles on a number of Presidential initiatives, boards and advisory councils.

He holds Master's and Bachelor's degrees in agricultural economics from the University of British Columbia.



Ms. Tatiana Molcean, Executive Secretary, United Nations Economic Commission for Europe (UNECE)

Ms. Molcean brings to the position twenty years of experience in the public sector with extensive international cooperation and development experience, and indepth knowledge and expertise across the entire ECE membership. She is currently the Permanent Representative of the Republic of Moldova to the United Nations Office, World Trade Organization and other international organizations in Geneva.

She served as State Secretary and Deputy Minister for Multilateral and Bilateral Cooperation in the Ministry of Foreign Affairs and European Integration (2017-2020), Deputy Director General for European Integration and Head of the Division for Economic and Sector Cooperation with the European Union (2012-2017) and Head of the Division for Economic Cooperation and Sectorial







Coordination at the General Directorate for European Integration (2004-2008). A career diplomat, she has also served as Chargé d'Affaires at the Embassy of the Republic of Moldova to Sweden (2008-2011).

Ms. Molcean holds a LLM Degree in Law from the Faculty of International Law at Moldova State University and completed the Multilateral Diplomacy Program from the Graduate Institute of Geneva, Switzerland. She is fluent in Romanian, English and Russian, with advanced knowledge of French.



Mr. José Manuel Salazar-Xirinachs, Executive Secretary, Economic Commission for Latin America and the Caribbean (ECLAC)

Mr. José Manuel Salazar-Xirinachs was appointed Executive Secretary of ECLAC by the United Nations' Secretary-General on September 1, 2022. He took office as from October 3, 2022. Previously he served as Regional Director for Latin America and the Caribbean of the International Labour Organization (ILO) from 2015-2018. He joined the ILO in 2005 as Executive

Director of its Employment Sector and served as Assistant Director General for Policy from 2013 to 2015. Prior to joining the ILO, he served from 1998 to 2005 as Director of the Trade Unit of the Organization of American States. Mr. Salazar was Minister of Foreign Trade of Costa Rica from 1997 to 1998, Executive President of the Costa Rican Development Corporation from 1988-1990 and Chief Economist and then Executive Director of a Central American private sector think tank (FEDEPRICAP) from 1990-1996. In the academic sphere, he is also the author of numerous journal articles on development, trade, productive transformation, competitiveness and employment policies, and has written and edited several books. He has taught at the University of Costa Rica, the National University of Heredia, Cambridge University and Georgetown University. He holds a master's degree in Development Economics and a doctorate in Economics from Cambridge University and a bachelor's degree in Economics from the University of Costa Rica.



Ms. Armida Salsiah Alisjahbana, Executive Secretary, Economic and Social Commission for Asia and the Pacific (ESCAP)

Prior to joining ESCAP, Ms. Alisjahbana was Professor of Economics at Universitas Padjadjaran in Bandung, Indonesia, a position she assumed in 2005. She joined Universitas Padjadjaran as a lecturer in 1988. Since 2016, she has served as Director for the Center for Sustainable Development Goals Studies at Universitas Padjadjaran and Vice Chair of the Indonesian Academy of Sciences.

She also serves on the Governing Board of the Economic Research Institute for ASEAN and East Asia (ERIA), and member of the Indonesian Academy of Sciences

(Akademi Ilmu Pengetahuan Indonesia - AIPI), the Forum of Statistics Community (Forum Masyarakat Statistik or Advisory Council of the Indonesian Statistics), the International Advisory Board of the Bulletin of Indonesian Economic Studies and Council Member of the Regional Science Association International (RSAI). From 2009 to 2014, she was Minister of National Development Planning and the Head of the National Development Planning Agency (BAPPENAS), Indonesia. She served as Co-chair of the Global Partnership for Effective Development Cooperation from 2012 to 2014. From 2009 to 2014, she was Alternate Governor of







the World Bank and Alternate Governor of the Asian Development Bank representing the government of Indonesia. In 2016, she was a member of the High Level Independent Team of Advisors to support the ECOSOC Dialogue on the longer term positioning of the United Nations Development System in the context of the 2030 Agenda on Sustainable Development.



Ms. Rola Dashti, Executive Secretary, Economic and Social Commission for Western Asia (ESCWA)

Ms. Dashti is a leading Kuwaiti economist and long-time champion of women's rights, gender equality and democratic reform. She served as member of the Supreme Planning Council in Kuwait. From 2012 to 2014, she was Minister for Planning and Development and Minister of State for Parliamentary Affairs. Ms. Dashti played a pivotal role in advocating for a decree to allow Kuwaiti women to vote and run for parliamentary elections. In May 2009, she and three others became the first women to be elected to

the Kuwait parliament.

She has held key positions in research and development institutions, such as the Kuwait Institute for Scientific Research, and has worked for major national and international financial and development institutions, such as the National Bank of Kuwait and the World Bank. She also managed contracts for the Kuwaiti Emergency and Reconstruction Program during the invasionto-post liberation period. Ms. Dashti holds a doctorate degree in population dynamics from Johns Hopkins University in Baltimore, a master's degree in economics and finance from California State University in Sacramento, and a Bachelor of Science in agriculture economics from California State University in Chico. She speaks Arabic and English fluently.



H.E. Mr. Krzysztof Szczerski, Permanent Representative of Poland to the United Nations and Vice-President of ECOSOC and Chair of the Commission for Social Development (CSocD) on its 63rd session

Krzysztof Szczerski was born in 1973 in Kraków. In 1997, he graduated from the Jagiellonian University with a master's degree in political science, and in 2001, he obtained his PhD at this university's Institute of Political Sciences and International Relations. He completed his habilitation (postdoctoral degree) in 2010, based on a dissertation entitled Dynamics of the European System, for which he received the Prime Minister's Award. In 2018, he was awarded the title of Professor of Social

Sciences.

Since 2000, he has been an affiliated scholar of the Jagiellonian University, and has twice been Deputy Director of its Institute of Political Sciences and International Relations. He lectured at the National School of Public Administration in 2008–2009 and later in Diplomatic Academy of the Ministry of Foreign Affairs. Since 2013, he has been an associate professor at the Jagiellonian University. Currently he is also a member of the Board of the Polish Institute of International Affairs and the Institute for Central Europe.

In the years 2007–2008, he was Undersecretary of State at the Ministry of Foreign Affairs, and then at the Office of the Committee for European Integration. He has been a member of the Civil Service Council to the Prime Minister (2009–2010) and a Deputy to the Polish Sejm (2011–2015). In January 2015, he became the





representative of the Polish Parliament at the Parliamentary Assembly of the Council of Europe. From 2015, he was Secretary of State at the Chancellery of the President of the Republic of Poland, from 2017, he served as Chief of the Cabinet of the President of the Republic of Poland and later as Head of the International Policy Bureau in the Chancellery.

In 2021, he assumed the office of Permanent Representative of the Republic of Poland to the United Nations in New York.



H.E. Mr. Abdulaziz M. Alwasil, Permanent Representative of Saudi Arabia to the United Nations and Chair of the Commission on the Status of Women (CSW) on its 69th session

Dr. Abdulaziz Alwasil took up his post as Ambassador and Permanent Representative of the Kingdom of Saudi Arabia to United Nations Headquarters in New York in July 2022 after serving as Ambassador and Permanent Representative to the United Nations Office at Geneva since November 2016.

Prior to his appointment at Geneva, Dr. Alwasil held various positions in the public and private sectors. Since joining the Diplomatic Service, he has concerned himself primarily with multilateral and human rights affairs in which he has gained extensive experience. He served as Deputy Head of Mission at Saudi Arabia's Embassy in London for more than three years. During his diplomatic career, he was also assigned to the Saudi Arabian Mission to the United Nations Office at Geneva and the Saudi Arabian Embassy in Australia.

At the beginning of his career, Dr. Alwasil worked as a college lecturer. He has had several articles on social and political issues published in Arabic and English.

Dr. Alwasil holds a PhD in International Relations, a Master's Degree in Political Science and a Bachelor's Degree in Arabic language and literature.



H.E. Ambassador Shambhu S. KUMARAN, Permanent Representative of India to the United Nations in Vienna and Chair of the Commission on Narcotic Drugs (CND) on its 68th session

During his career, Mr. Kumaran, who is also an Ambassador to Austria as well as The Holy See and Montenegro, has served in various capacities, among them:

Ambassador to the Philippines, Palau and Micronesia (2020-2024); Ambassador to Morocco (2019-2020); Joint Secretary (Planning and International Cooperation), Ministry of Defence (2016-2019); Director (East Asia/China),

Joint Secretary (Establishment) and Joint Secretary (Eurasia), Ministry of Foreign Affairs (2012-2016); Deputy High Commissioner to South Africa (2009-2012); Political Counsellor in Kathmandu (2007-2009); Officer on Special Duty (Press Relations), External Publicity Division, Ministry of Foreign Affairs (2004-2007); Deputy Secretary (West Europe Division), Ministry of Foreign Affairs (2002-2004); and diplomatic assignments in Germany (1997-2002).





Mr. Kumaran holds a Master of Arts in international studies and a Master of Philosophy in diplomatic studies from Jawaharlal Nehru University, New Delhi as well as a Bachelor's degree in English Literature from Kerala University.

Mr. Kumaran speaks English, Malayalam, Hindi, French and German.



H.E. Mr. José Antonio ZABALGOITIA, Permanent Representative of Mexico to the United Nations in Vienna and Chair of the Commission on Crime Prevention and Criminal Justice (CCPCJ) on its 34th session

Born in Mexico City, he joined Mexico's Foreign Service in 1988, and became Ambassador in 2009.

He holds a Bachelor's Degree in International Relations from El Colegio de México, a Master's degree in that same field from the London School of Economics and Political Science; and another Master on National Security from Mexico's War College. He also did graduate courses on Political Communication and on Peace Research.

Ambassador Zabalgoitia has built a diverse, yet well-balanced diplomatic career. His major fields of expertise are: Latin America, Press and Communication, and Mexico - United States relations. He also combines bilateral and multilateral experience, where he has had important responsibilities regarding Mexico's participation in regional and global fora and organizations.

He served as Consul General of Mexico in Miami, FL, from 2013 to 2017, when he was designated deputy ambassador to the United States of America. He supported negotiations that allowed to update NAFTA into USMCA in November 2018. He then represented Mexico in the Netherlands from 2019 to 2023. He was also Permanent Representative to the Organization for the Prohibition of Chemical Weapons and the international legal organizations established in The Hague, among them the International Criminal Court and the International Court of Justice.

He has served as Chief of Staff to the Secretary of Foreign Relations, where he was responsible for coordinating the Secretary's participation in Cabinet meetings and for preparing hearings before Congress. In that position, he conducted the strategic planning process for the foreign policy chapter in the 2006 - 2012 National Development Plan.

He was Mexico's National Coordinator for 28 regional political and economic fora. Among others, he oversaw Mexico's participation at the Organization of American States and coordinated the design and implementation of the Pacific Alliance on behalf of Mexico. Within the Alliance, he led the working groups dealing with communications and migration issues.

He coordinated the Rio Group during Mexico's tenure as its Pro Tempore Secretariat, in a process that culminated with the creation of CELAC. Overall, he prepared Mexico's participation at the highest level in 18 regional and hemispheric summits. He also served as Director General for Latin American Affairs, where he conducted bilateral relations with the region.







He was appointed Ambassador to Bolivia and served as Press Counselor at the Embassy in Spain and Minister for Public Affairs at the Embassy in the United States. Previously, was Director of Bilateral Relations with the U.S. and for Canadian Affairs during the negotiation of NAFTA.

Since December, 2023, he serves as Ambassador to Austria, Slovenia and Slovakia, and Permanent Representative to the United Nations Office in Vienna and other international organizations based in this city.

He has published articles on Mexican and Latin American foreign policy and lectured at Mexico's main academic institutions. He was awarded the S.H. Bailey Prize in International Relations in 1987.



H.E. Mr. Muhammadou M.O. Kah, Permanent Representative of The Gambia to the United Nations in Geneva and Chair of the Commission on Science and Technology for Development (CSTD) on its 28th session

His Excellency Professor Muhammadou M.O. Kah is the Ambassador & Permanent Representative of The Gambia to the UN Office at Geneva, World Trade Organisation (WTO), and other offices in Geneva. He currently Chairs the Africa Group of Ambassadors at Geneva (April 2021-June 2021) and is the Vice Chair for UNCTAD's Commission on Science and Technology Development's 25th session and a member of the Advisory Board of the UNCTAD TDB Advisory Body (June 2021-July 2022). Ambassador Prof. Kah is also one of three Ambassadors designated as Friends of the Chair of the World Intellectual Property Organisation (WIPO) General Assembly.

Prior to his appointment in Geneva, Professor Kah served as the Founding Chairman of Zenith Bank, The Gambia, Chairman of the Board of Directors, Africa Consulting & Trading Group (ACT), Dakar, Senegal and as the first Gambian-born third Vice Chancellor of The University of The Gambia (UTG) from 2009- 2015 and recently appointed as a Visiting Professor at the Faculty of Humanities, University of Johannesburg, South Africa.

Prior to becoming UTG's Vice Chancellor/Rector in 2009, Professor Muhammadou M.O. Kah spent 4 years in Nigeria as the Founding Dean of the School of Information Technology and Communications at the American University of Nigeria (AUN) where he doubled for a year as Interim Dean of the School of Business & Entrepreneurship. Professor Kah was appointed as Vice President of Academic Affairs & Provost (DVC) and Professor of Information Technology & Computing at the American University of Nigeria, Yola, Adamawa State (2017-2020). He also served as Vice Rector for Technology & Innovation; Professor and Founding Dean of the School of Information Technology & Engineering at ADA University in Baku, Azerbaijan (2015-2017). He served at the Board of Trustees and Governing councils of the American University of Nigeria and the African University of Science and Technology, Abuja, Nigeria.

Professor Kah has held teaching and leadership positions in the USA, Africa, the Middle East (Gulf countries) and Eastern Europe (Caucuses). A regular contributor to the "Africa Module" in the Advanced Leadership Program (ALP) at Cambridge Judge Business School, he was appointed as an honorary Fellow of the Judge Business School and the Digital Innovation Centre, University of Cambridge (2016-2017). Professor Kah is passionate about advancing and strengthening computing, engineering, science, and leading strategy &





innovation in organizations. To complement that he also provides thought leadership in information technologies & computing education in higher education whilst also serving as a member of international panels such as the Malabo Montpellier Panel, the Euro Science Forum 2018, Africa Europe Foundation, amongst others.

Completing his BSc, MSc. and Ph.D. at the Stevens Institute of Technology, Hoboken, New Jersey, one of the top engineering and technology management universities in the USA, Professor Kah also holds a Master of Science in Finance (Financial Engineering) from George Washington University, Washington, DC and a Postgraduate Diploma (Dip SI) in Strategy and Innovation from the Said Business School, University of Oxford, UK.

Professor Kah has completed several Executive Education Programs: University of Cambridge, Judge Business School: the Advanced Leadership (ALP) Program; Advanced Leadership Re-Union & Follow-Up Program in Singapore and Beyond Innovation: Business Models for Transformation & Competitive Advantage; Harvard University, Harvard Kennedy School: Transforming Leadership for 21st Century Africa, and The AGA KHAN University, Graduate School of Media & Communication: The Voice of Leadership; Inspiration, Influence & Impact. In Corporate Governance, he has completed the highly reputable International Directors Program (IDP) as an Internationally Certified Director from INSEAD, through the INSEAD Singapore and Fontainebleau, France, Campus. Professor Kah is also a member of the Institute of Directors (IoD), London, UK.



Mr. Georges-Simon Ulrich, Director General of the Swiss Federal Statistical Office (FSO) and Chair of the Statistical Commission on its 55th session

Prior to that, he was posted to the Embassy of Beijing in 1998 as Second Secretary, where he served for four years. He served in different divisions and sections at the Ministry of Foreign Affairs of Nepal after joining the Foreign Service of Nepal in 1990. In his long diplomatic career, Mr. Thapa became a part of high-level Nepali delegations to different countries as well as attended dozens of bilateral, regional and multilateral meetings, conferences and negotiations. H.E. Ms. Elina Kalkku, Permanent Representative of Finland to the United Nations and co-Chair of the STI Forum

Prior to the current position, Ms. Kalkku served as Under-Secretary of State at the Ministry for Foreign Affairs of Finland, responsible for development policy and relations with African and Middle Eastern countries. Prior to that, she served as Director-General of the Department for Americas and Asia in 2005-2015. In 2000-2005, she served as Director of the Security Policy unit at the Political Department of the Ministry.

Ms. Kalkku joined the Ministry for Foreign Affairs in 1983. She has previously served abroad at the Finnish Mission to the UN in New York (1987-1991) and the Finnish Mission to Nato in Brussels as well as at the Finnish Embassies in Madrid and Brussels.

Robert Powell is the International Monetary Fund's Special Representative to the United Nations. His extensive experience at the IMF includes policy development, aid effectiveness, country operations, debt relief activities, and capacity building. He has been chief of the strategy and evaluation division of the Institute for Capacity Development (2014-2019); led the concessional financing division of the Finance Department (2009-14); helped develop the

joint IMF and World Bank Heavily Indebted Poor Countries (HIPC) debt relief initiative; and served as mission chief for Liberia and The Gambia. Earlier in his career he worked at the UK Treasury including as Paris Club representative, the Institute of International Finance, and at the World Bank. Mr. Mathew Olusanya Gbonjubola is a fellow of the Institute of Chartered Accountants of Nigeria and a member of the Chartered Institute of Taxation of Nigeria. He obtained the Higher National Diploma in Accountancy from The Polytechnic, Ibadan (1987) and Masters of Business Administration from the Obafemi Awolowo University, Ile-Ife (1999). Mr Gbonjubola joined the FIRS in

1997 as Principal Inspector of Taxes. He served in several positions in tax audit, tax investigation, tax policy, transfer pricing and international tax functions. He rose to the rank of Director and was appointed to lead the Special Tax Operations Group in 2021. In the course of his tax career, he had extensive exposure in the international tax arena representing Nigeria on many international tax bodies. He is Co-Chair of the UN's Committee of Experts on International Cooperation in Tax Matters (2021 – Date); Co-Vice Chair of the G20 Inclusive Framework on BEPS 2016 – Date); Nigeria's delegate to G24 Working Group on Taxation (2020 – Date); Co-Chair of OECD Working Party 6 (on Transfer Pricing) (2018 – 2022); Chair of the Cross- Border Taxation (CBT) Committee of the African Tax Administration Forum (ATAF) (2016 – 2020)

Mr Gbonjubola was listed among the World's Top 50 Tax Persons for the year 2022 by International Tax Review (ITR).



Ms. Rebeca Grynspan, Secretary-General of the United Nations Conference on Trade and Development (UNCTAD)

Rebeca Grynspan, of Costa Rica, became UNCTAD's eighth Secretary-General on 13 September 2021 and is the first woman to lead the organization.

Prior to her UNCTAD appointment, she was the Ibero-American secretary-general from 2014 to 2021, also the first woman to head the organization. During her mandate, she has coordinated the 22-member Iberoamerican Conference and led four key summits of Heads of State and Government.

In 2010 she was appointed Under-Secretary-General of the United Nations and Associate Administrator of the United Nations Development Program (UNDP) and prior to that was UNDP Regional Director for Latin America and the Caribbean.

Prior to joining the United Nations, Ms. Grynspan served as Vice-President of Costa Rica from 1994 to 1998. She was also Minister of Housing, Minister Coordinator of Economic and Social Affairs, and Deputy Minister of Finance. In 2021 she was named Special International Advisor to the newly created Economic and Social Council of Argentina and invited to join as member of the G20 High-Level Independent Panel on Financing the Global Commons for Pandemic Preparedness and Response.

In addition to her experience as a lecturer and advisor to several international organizations, she has been actively involved in key United Nations initiatives, such as the Millennium Project's Task Force on Poverty and Economic Development and the High-level Panel on Financing for Development. In 2014 and 2015, she was recognized as one of the 50 leading intellectuals of Latin America. And she was recognized as one of the 100 most powerful women in Central America by Forbes magazine.







Ms Grynspan holds a degree in Economics by the University of Costa Rica and a MSc in Economics by the University of Sussex. She has been awarded a Doctorate Honoris Causa by the University of Salamanca, the University of Extremadura and the European University of Madrid in recognition of her outstanding professional achievements.



Ms. Rabab Fatima, High Representative for Least Developed Countries, Landlocked Developing Countries and Small Island Developing States

United Nations Secretary-General António Guterres announced on 9 June 2022 the appointment of Rabab Fatima of Bangladesh as High Representative for the Least Developed Countries, Landlocked Developing Countries and Small Island Developing States (UN-OHRLLS). She succeeds Courtenay Rattray of Jamaica who was appointed as the Chef de Cabinet.

The Secretary-General wishes to extend his appreciation and gratitude to Heidi Schroderus-Fox of Finland, who is the Deputy to the High Representative and

Director of UN-OHRLLS, for her dedication and commitment as Acting High Representative.

Ms. Fatima brings to the position more than 30 years of experience in national and international Civil Service, encompassing bilateral and multilateral diplomacy, policy-making, advocacy, programme planning and implementation.

She is the current Ambassador and Permanent Representative of Bangladesh to the United Nations in New York. Prior to this position, she was the Ambassador of Bangladesh to Japan (2016-2019), Director-General of the Ministry of Foreign Affairs in Bangladesh (2015-2016), Regional Representative for South Asia (2007-2011) and Regional Adviser for South and Southwest Asia and Regional Adviser for Climate Change and Migration (2012-2015) of the International Organization for Migration (IOM), Geneva and Head of Human Rights at the Commonwealth Secretariat, London (2006-2007).

Ms. Fatima joined her country's Diplomatic Service in 1989 and served in various capacities in the Ministry of Foreign Affairs and in Bangladesh Missions in New York, Kolkata, Geneva and Beijing.

She holds a master's degree in International Relations and Diplomacy from the Fletcher School of Law and Diplomacy, Tufts University and a Bachelor's degree in Social Science from the University of Canberra, Australia.



H.E. Mr. Osama Mahmoud Abdelkhalek Mahmoud, Permanent Representative of Egypt to the United Nations and Chair of the Group of African States for the month of February 2025

H.E. Mr. Osama Abdelkhalek became the Permanent Representative of Egypt to the United Nation on September 16, 2021.

Before his latest appointment, Ambassador Abdelkhalek served as Permanent Representative to the African Union and the Economic Commission for Africa

(ECA) between October 2018 and August 2021.





Having been appointed Deputy Minister for Foreign Affairs in July 2016, he was in charge of African affairs until October 2018. From July 2011 to July 2016, he was posted to the United Nations in New York as Deputy Permanent Representative, after having served as a counsellor in the Cabinet of the Minister for Foreign Affairs since June 2009.
