Mr. Thomas Friedman (United States) is a New York Times columnist and Pulitzer Prize winning author, renowned for his books including "the Lexus and the Olive Tree" and "The World Is Flat". He has written several other books, including "Hot, Flat and Crowded," and "From Beirut to Jerusalem." Mr. Friedman received his B.A. degree in Mediterranean studies from Brandeis University. He received a master's in modern Middle East studies from Oxford. He joined the New York Times in 1981, served as the Beirut and Jerusalem bureau chief, diplomatic correspondent and later the White House correspondent and economic correspondent. His new book, "Thank You For Being Late: How to Find a Job, Run a Country, and Keep Your Head in an Age of Acceleration", will be released later this year.
