It was also decided that the Commission would contribute to the follow-up and review of the 2030 Agenda for Sustainable Development within its existing mandate. In its decision 2017/260, ECOSOC decided that, starting with the 53rd session of the CPD in 2020, the Commission would adopt a four-year cycle for the review and appraisal of the implementation of the ICPD Programme of Action and its contribution to the follow-up and review of the 2030 Agenda, as part of a multi-year work programme aligned with the Council's main theme and with the thematic focus of the high-level political forum convened under the auspices of the Council.

The elected members serve for a term of office of two years, in parallel with the review and policy cycle. At its 56th session (Feb. 2018), CSocD reviewed its methods of work and adopted a resolution on its future organization and methods of work. The commission reaffirmed that it will contribute to the follow-up to the 2030 Agenda, within its existing mandate, by supporting the thematic reviews of the HLPF on progress in the implementation of the SDGs, including cross-cutting issues. At its 60th session, CSW adopted a resolution on "Multi-year programme of work of the CSW" in which it decided on priority and review themes for its 61st (2017), 62nd (2018) and 63rd (2019) sessions. At its 59th session, CSW reviewed its methods of work, in which it decided "that the Commission will report on the aspects relating to gender equality and the empowerment of women of the agreed main theme of the ECOSOC, in order to contribute to its work (OP3 of E/RES/2015/6). It also decided that the Commission will, as necessary, continue to discuss emerging issues, trends, focus areas and new approaches to questions affecting the situation of women, including equality between women and men, that require timely consideration, taking into account developments at the global and regional levels as well as planned activities within the United Nations, where increased attention to gender perspectives is required, and with attention to relevant issues on the agenda of the Council, in particular its annual main theme, as applicable (Op10).

				In addition, the Commission decided in June 2019 on a multi-year workplan to organize thematic sessions on the practical implementation of international drug policy commitments. These thematic sessions are held every autumn in the lead up to 2024 and provide another opportunity for the other functional commissions to contribute to the work of the CND, highlighting cross-cutting issues.

The Commissions have devoted special attention to the issue of gender mainstreaming, joining efforts to promote the use of genderinclusive communication, including through the "Let's Talk Gender" meetings. Other ECOSOC subsidiary bodies are invited to contribute to the work of the Commission, including under the agenda item on contributions to the work of the ECOSOC. At its 29th regular session, the Commission is expected to consider the outcome of the 14th United Nations Congress on Crime Prevention and Criminal Justice (20-27 April Kyoto, Japan), for which it acts as the preparatory body as well as the body that translates the guidance provided by the Congress into concrete action. The main theme of the Fourteenth Congress is "Advancing
