He holds BA degrees in Philosophy, Political Science and International Studies, as well as in History. He has an MA degree in Turkic Studies from University of California. He is advanced to candidacy for PhD in Turkic Studies, Department of Languages and Cultures, University of California. He is fluent in English, French, Russian, Persian, Arabic, Azerbaijani,

Uzbek, Uyghur, Ottoman Turkish, and Chagatai.

Francisco Sagasti is professor at the Graduate School of the Universidad del Pacífico; senior researcher emeritus and former Executive Director of FORO Nacional/Internacional, an independent think-tank; member of the International Advisory Board of the Lemelson Foundation; and advisor to private corporations, international organizations, foundations and public sector agencies on strategy issues. Dr. Sagasti has been, among others,

chairman of the Board of the Science and Technology Program at the Prime Minister's Office in Peru; member of the Board of Governors of the Canadian International Development Research Centre (IDRC), and of the International Institute for Environment and Development (IIED). He holds engineering degrees from the National Engineering University in Lima, Peru, an MSc in industrial engineering from Penn State University, and a Ph.D. in operations research and social systems sciences from the University of Pennsylvania. Dr. Sagasti has published more than 25 books and is also the author of more than 150 papers and book chapters.
