In that capacity, he was, among others, also the Director of the International Policy Centre for Inclusive Growth, UNDP's global forum for policy dialogue and

South-South learning on social development innovations. Born in 1960, he holds a Master of Science in Foreign Service (honors) from Georgetown University in Washington, D.C., and a Bachelor of Science in Political Science from Catholic University in Buenos Aires, Argentina.
