## Draft Programme <u>Repositioning the United Nations development system</u> <u>to best deliver for people and planet</u>

The 2018 ECOSOC Segment on Operational Activities for Development will serve as a key platform for Member States and other stakeholders to discuss the proposals of the Secretary-General to reposition the UN development system to respond to the requirements of the 2030 Agenda. The Segment will also provide an opportunity for Member States and stakeholders to take stock of the implementation of General Assembly resolution 71/243 on the quadrennial comprehensive policy review of operational activities for development of the UN system.

- What needs to change in the profile of teams at country, regional and global levels to enable delivering strategically on capacity development needs, including how to leverage the kind of financing and partnerships needed for the 2030 Agenda?
