By respecting human rights, we will also take a major step in implementing the Sustainable Development Goals.

Through tackling inequality, combating exclusion and poverty, and ensuring that the benefits of development are shared.

During the SDG Summit here in New York in September, we re-committed to: achieving the SDGs, to leaving no one behind, and resolved to make the coming decade one of action and delivery for sustainable development.

Girls, who no longer need to interrupt their learning because the school does not have adequate sanitation facilities.

Families, freeing themselves from the grip of inequality and poverty. And elders, and youth not needing to go to bed hungry.

In short - we are talking about all people being truly 'free and equal in dignity and rights'.

We know also that currently we are lagging behind in achieving our goals.

We all need to work together to formulate a way forward. One driven by innovative and practical steps to bring about the change we want.

But, we are running out of time and this is a race we cannot afford to lose.

ECOSOC stands ready to work with you: to disseminate the recommendations from this meeting; to help to guide discussions in New York, and across regions; and hopefully to prompt uptake and implementation at the national level.

The report of this meeting will be an important input into the Highlevel Political Forum on Sustainable Development (HLPF). And we pledge to make good use of it.

In conclusion, let me reiterate the great importance of building on, and strengthening, existing collaboration between ECOSOC and the Human Rights Council.

I had the opportunity to join you in Geneva in September to address the Council, and to brief on the work of the HLPF, as did my predecessor the year before. And very much hope this will become a well-established tradition.
