Module 2: A tailored and targeted United Nations development system's support to countries' efforts to advance the 2030 Agenda Tuesday 16 June 2020, 9:30am – 1:00pm

Objective: This module would target a bird's eye view and interactive discussion of how the UN development system is responding to the guidance of Member States under the twin resolutions on the 2016 Quadrennial Comprehensive Policy Review and the UNDS repositioning, to support the delivery of the 2030 Agenda in the context of the increasingly diverse needs, capacities and priorities of programme countries.

This session is envisaged to start with 4 presentations followed by a "Davos-style" moderated discussion, between speakers, discussants and participants from the floor and from other locations in the world. It would start with the overall direction, purpose and expectations of the UN reforms, particularly that of the UNDS required in support of the delivery of the 2030 Agenda; this would be followed by an overview of the key elements of the UNDS reform process, the relation between these elements, as well as the different levels [country, regional, global) and some thoughts on what still need to change, and how could it be reflected in decision-making processes of governing boards and resolutions by ECOSOC and the General Assembly. Two delegates, one each from North and South, would then present and discuss with one another the thinking, objectives and approaches that delegates had in mind when negotiating the 2016 QCPR. This would be followed by a presentation by UNFPA of the impact of the repositioning on the ground from their perspective, as well as the UNFPA business model of country support that has been in place for the past several years, and lessons learned from the process, Discussants will touch on achievements as well as ideas on how to address remaining challenges, from the perspectives of LDCs, LLDCs, SIDS, MICs, countries in special situations as well as non-programme countries.

Participants will be invited to engage very actively throughout the session by asking questions, proposing ideas, challenging or defending various concepts and notions.

Module 3: Funding UN operational activities for development and Financing the SDGs Tuesday 2 July 2020, 9:45am – 1:00pm

Objective: This module will present an overview of the <u>funding</u> of the UN's operational activities for development, including current trends and issues, as well as progress and challenges on the implementation of related mandates. The session will review the <u>Funding Compact</u>'s objectives and key elements, which emphasizes greater transparency and accountability on the part of the system in exchange for higher quality and more predictable resources, and <u>recent progress on the Compact's indicators</u>, and also delve into the subject of efficiencies that were part of the repositioning commitments. As funding the UN system is one sub-set of the larger discussion on financing for development, an exchange of views will be promoted on the role of the UN development system in terms of supporting countries to finance the SDGs. A discussion will follow between panellists and participants, led by the moderator.
