### THE 1963 WORLD PROGRAMME OF BASIC INDUSTRIAL STATISTICS

1. The Statistical Commission adopted the following resolution at its eleventh session:  $\frac{1}{\sqrt{}}$ 

"Requests the Secretary-General to prepare a publication setting out the recommendations for the 1963 World Programme of Basic Industrial Inquiries as approved by the Commission;

"Calls the attention of the Governments of States Members of the United Nations to resolution 676 B (XXVI) of the Economic and Social Council, which recommended the compilation of basic data on industry for 1963, or a year close to 1963, taking into account as far as possible the international recommendations on this subject;

"Invites the Secretary-General to provide technical guidance and assistance, in the planning and conduct of inquiries that are to be part of the 1963 World Programme, by means of technical studies and seminars and the provision of expert assistance, and means for regional consultations."

This paper consists of a report on the steps taken to carry out this resolution and on national plans to participate in the 1963 World Programme.

### I. INTERNATIONAL RECOMMENDATIONS AND REGIONAL CONSULTATIONS

### A. THE WORLD RECOMMENDATIONS

2. The recommendations of the Statistical Commission on the 1963 World Programme, together with background material on the history, nature and purpose of the recommendations and on alternative ways of gathering the recommended data, were published in <u>International Recommendations on the 1963 World Programme of Basic Industrial Statistics.</u>

This publication was distributed to national statistical authorities in order to call to their attention, the recommendations of the Economic and Social Council and the Statistical Commission on the 1963 World Programme.

- 3. The recommendations adopted by the Commission concerned a minimum body of statistics that should be made available on an internationally comparable basis for 1963 or a year close to 1963. The recommendations therefore set out the different statistics to be compiled, the characteristics (e.g., kind of activity or size) of the statistical unit and the associated schemes of classification to be utilized in tabulating each of these statistics, and the field of economic activity to be covered by the data. Since the meaning and usefulness of the statistics depend on how they are defined and derived, the proposals also covered the items of data to be gathered for purposes of compiling the suggested statistics, the kind of statistical and tabulating unit to be utilized in gathering and compiling these items, and definitions for the suggested items of data and statistics. The recommendations provided for use of the establishment or the equivalent local unit as the statistical and tabulating unit for the 1963 World Programme. Further, the recommendations indicated the order of priority which the Commission attached to the gathering and compilation of various statistics for small and large units. The Commission assigned first priority to a more abbreviated list of items for small units than for large units. The full list of statistics recommended for small units, including the items to which a second order of priority was assigned, was also shorter and less detailed than the list of statistics recommended for large units. The Commission may recall that it adopted this approach in view of the differences between small and large units in the difficulties and the costs that were likely to be encountered in gathering various items of data.
- 4. The Commission emphasized that the recommendations on the 1963 World Programme were designed to yield a minimum body of comparable basic industrial statistics for national, as well as international, use and that these recommendations were not intended to curtail the content of national inquiries which would be taken as part of the 1963 World Programme. In fact, it was recognized that in many countries it would be found both desirable and practicable to take much more ambitious and detailed inquiries than provided for in the international suggestions. Also, the Commission did not include in its recommendations, proposals on the way in which to gather the statistics since the appropriate approach and methods would vary, depending on the national circumstances under which the inquiry was taken. Nevertheless the Statistical Commission felt that it would be useful to countries

which are statistically less advanced if the publication on the 1963 World Programme included a discussion of the broad alternatives for gathering the recommended items of data and the factors which should be taken into account in making a choice among these alternatives under various circumstances. Accordingly, a part of the introduction to the publication, <u>International Recommendations on the 1963 World Programme of Basic Industrial Statistics</u>, is devoted to these questions.

### B. THE REGIONAL RECOMMENDATIONS

Regional adaptations of the 1963 World Programme have been considered by the Committee on Improvement of National Statistics and the Conferences of Asian and European Statisticians and will be dealt with by the Conference of African Statisticians in the near future. The Committee on Improvement of National Statistics and the Conference of European Statisticians have adopted recommendations for the Americas and Europe, respectively, which fit into the 1963 World Programme. 4/ In the case of Asia, the last step in adopting a set of regional proposals is now being taken. The Conference of Asian Statisticians considered, at its last plenary session, in November-December 1961, a proposed adaptation of the 1963 World Programme, which was based on the discussions of the Seminar on Industrial Statistics for Asia and the Far East. The Conference requested that some amendments be made in these proposals. These amendments are being made. and the resulting 1963 programme for the region of the Economic Commission for Asia and the Far East will be circulated to countries for comment before becoming the definitive recommendations of the Conference of Asian Statisticians. Adaptations in the 1963 World Programme that may be required in the case of Africa will be discussed at the ECA Seminar on Industrial Statistics, which will be held in June 1962.

- The regional variants of the 1963 World Programme adopted in the Americas and Europe recommend a more extensive list of statistics for large industrial units than that included in the recommendations of the Statistical Commission. In both cases, the list of statistics and items of data included for larger units is that for an infrequent inquiry in the recommendations on basic industrial statistics that the Statistical Commission formulated as a guide to countries in the full development of these data on an internationally comparable basis. 6/ For example. these recommendations include items on the number of employees and wages and salaries paid to them, sub-divided into operatives and other employees and on man-hours worked by operatives, which were excluded from the 1963 World Programme. In the case of small units, the abbreviated list of items of data included in the two sets of regional recommendations has essentially the items to which the Statistical Commission assigned a priority of one in its recommendations on the 1963 World Programme. The Committee on Improvement of National Statistics suggested that at least the abbreviated list of statistics be gathered on small units where it was not considered desirable and feasible to utilize the more extended list recommended for the larger units. The Committee also proposed that establishments with less than 10 persons engaged be considered small units. Neither of the two regional programmes assigned orders of priority to the various items of data.
- 7. The definitions of the statistics and items of data in the programmes for the Americas and Europe are essentially the same as those in the Commission's recommendations on the 1963 World Programme or on fuller basic industrial inquiries. In some instances, it was feasible to include more restrictive and precise definitions in the regional recommendations than in the Commission's recommendations. The proposals of the two regional organizations provide for more extensive classification of the statistics to be compiled than the proposals of the Statistical Commission. The Committee on Improvement of National Statistics added classification according to kind of legal organization to the classifications according to kind of economic activity and size that were suggested by the Commission. The Conference of European Statisticians recommended classification,

in certain instances, according to more detailed categories of kind of activity than the three-digit level of the International Standard Industrial Classification of all Economic Activities. The European programme includes, in addition, a standard list of commodities for which it is recommended that data be compiled on total production in physical terms or, in some cases, in value terms. The suggestions of the Committee on Improvement of National Statistics and the Conference of European Statisticians on the field to be covered and the statistical unit to be utilized in the 1963 Programme are the same as the recommendations of the Commission.

- 8. In addition to recommendations on the items to be gathered and compiled for establishments or the equivalent local unit, the European programme includes proposals on the statistics to be compiled for enterprises. This subject is covered in view of the wide interest in Europe in describing the industrial sector and activities in terms of enterprises and in delineating the structural and statistical relationships between enterprises and their constituent establishments or local units. The statistics proposed for compilation for enterprises consist of a selection from among those suggested for establishment-type units in the main, summary data on various aspects of industrial activity. The kinds of economic activity to be covered are the same as those in the 1963 World Programme namely, mining, manufacturing, construction and the electricity, gas and steam industries. The alternative definitions of the enterprise in the European recommendations were taken from the Commission's recommendations on a full programme of basic industrial statistics.
- 9. It seems likely that the recommended programme for the region of the Economic Commission for Asia and the Far East will include more items of data than the 1963 World Programme. For example, items may be added on the number of employees engaged during several periods of the inquiry year and acquisitions of and gross additions to fixed assets for small units and on the cost and quantity of individually important raw materials received or consumed for both large and small units. On the other hand, it may be recommended that data be sought on the combined number of working proprietors and unpaid family members engaged in the work of the establishment. It seems likely that this set of regional recommendations will be essentially the same as the 1963 World Programme in all other respects.

### II. SEMINARS ON INDUSTRIAL STATISTICS

10. Seminars on industrial statistics have been held for the members and associate members of the Economic Commissions for Latin America and for Asia and the Far East; and such a seminar will be convened for the region of the Economic Commission for Africa in June 1962. The seminars have been organized in order to furnish the opportunity for detailed discussion of and exchange of national experience on practical systems of inquiries that will yield the basic and current industrial statistics required for planning, assessing and furthering industrial development, as well as for other purposes. In discussing the infrequent, annual and monthly or quarterly inquiries that should make up the required full system of industrial statistics, particular attention has been paid to the benchmark inquiries that will be taken as part of the 1963 World Programme of Basic Industrial Statistics. Emphasis has been given to the key role of these inquiries in (i) providing the required basic data on the structure and activities of the industrial sector of the economy and (1i) furnishing the basis for devising or extending and improving annual and monthly or quarterly inquiries, with a view to developing a comprehensive and integrated system of industrial statistics. In covering benchmark inquiries, such as those that will be part of the 1963 World Programme, and annual and monthly or quarterly surveys, the Seminars have dealt with each aspect of planning and carrying out these inquiries and publishing the results. Included in the discussion, for example, were the objectives of various kinds of inquiries (i.e., the items of data to be gathered, the statistics to be compiled, the statistical and tabulating unit to be employed, and the field of industrial units to be covered); the way in which the items might be defined, gathered and classified; and the questionnaires, tables and schemes of classification that might be employed for these purposes. Also covered in the proceedings of the Seminars were the alternative means of gathering the data (e.g., records that were a by-product of governmental administration, censuses, or various types of sample design); and alternative techniques of taking censuses or sample inquiries (e.g., mail inquiries based on an industrial directory; field canvassing and enumeration, based on such a directory; or exhaustive field canvassing for and enumeration of the units to be included in the inquiry). In the case of each alternative, the Seminars considered the details of the involved methods, forms and procedures and the character and magnitude of the required resources, as well as the circumstances under which it was appropriate to utilize the alternative E/CN.3/288 English Page 8

under discussion. In connexion with current industrial inquiries, the Seminars also covered the compilation of index numbers of industrial production and employment and of other indicators.

11. The Seminar for Latin America was organized by the Economic Commission for Latin America, the Bureau of Technical Assistance Operations, the Statistical Office of the United Nations and the Inter-American Statistical Institute, in co-operation with the Government of Chile, which was the host Government. The attendance of two participants from each member or associate member, located within the region, of the Economic Commission for Latin America and the other expenses involved in the Seminar were provided for from technical assistance funds. These funds were furnished by the Bureau of Technical Assistance Operations and the Inter-American Statistical Institute. Forty-four participants attended the Seminar; each member and associate member, located within the region, of the Commission for Latin America was represented. The attendance of some participants was financed by their own Government or organizations other than the sponsors of the Seminar. The Seminar was in session from 10 through 28 October 1960. The proceedings and conclusions of the Seminar are set out in a report that the Seminar adopted during its last few sessions. If

The proceedings and conclusions of the Seminar, as well as the papers on which the discussions were based, are set out in Report of the Seminar on Industrial Statistics.

### III. NATIONAL PARTICIPATION IN THE 1963 WORLD PROGRAMME

13. It may be noted from Annex I to this paper that somewhat over 90 countries are known to be planning to participate in the 1963 World Programme of Basic Industrial Statistics. All countries in the Americas, the region of the Economic Commission for Asia and the Far East, and in Europe will take inquiries for 1963 or a year close to 1963 which will yield the required data. Available information indicates that thirteen countries and territories in Africa plan to take such inquiries.

14. A number of the countries and territories will have the data for the 1963 World Programme as a result of taking infrequent or annual inquiries which are part of their regular system of industrial statistics. Some of them will find it necessary to extend the field of establishments covered in these inquiries in order to gather the required data. In the case of other countries, a combination of two or more surveys - for example, a census for large units and a sample survey for the smaller units or separate inquiries for the various divisions of the industrial sector will be utilized for this purpose. Approximately 20 countries will be taking their first comprehensive inquiry into the industrial sector as part of the 1963 World Programme.

### IV. PLANS FOR TECHNICAL ASSISTANCE AND RELATED ACTIVITIES

15. During the course of the Seminars on Industrial Statistics in Latin America and Asia and the Far East, a number of participants indicated that technical assistance would be needed and desired in their country for purposes of taking and/or planning inquiries that would be part of the 1963 World Programme of Basic Industrial Statistics. In addition, the Seminar for Asia and the Far East "strongly recommended that provision be made for: (i) Expert assistance and fellowships for countries with relatively little experience in the field of industrial statistics; (ii) Regional advisory services, similar to the regional census advisory services, made available to countries as and when requested, at crucial stages in planning and executing industrial inquiries under the 1963 World Programme". These recommendations were supported by the fourth session of the Conference of Asian Statisticians.

16. For the above purposes, efforts have been made to provide, through technical assistance funds, for the stationing of one or two regional economic statisticians at the headquarters of the Economic Commissions for Asia and the Far East and Latin America, respectively. Thus far, the approved 1962 Programme of Technical Assistance in the field of statistics provides for one regional economic statistician in Latin America for the latter half of 1962. It is proposed that the programme for 1963-1964 include a regional economic statistician for each of the areas. The 1962 Programme also includes 10 country projects specifically in industrial statistics and other country projects in economic statistics which may involve technical assistance in planning or taking industrial inquiries.

17. The plans for technical assistance in connexion with the industrial inquiries to be taken for 1963 or a year close to 1963, as well as the development of national systems of industrial statistics, also call for a revision of Volumes I and II of the publication Industrial Censuses and Related Enquiries.
