I. INTRODUCTION

- 1. This paper concerns proposed modifications in the draft revised International Standard Industrial Classification of All Economic Activities (ISIC) set out in document E/CN.3/359. The changes suggested in the draft revised ISIC reflect the views of the majority of national statistical authorities concerning the classification scheme. Document E/CN.3/359 was circulated to national statistical offices and interested international bodies for comment and was the main subject of discussion by the second session of the Working Group on Activity and Commodity Classification of the Conference of European Statisticians. $\frac{1}{2}$
- 2. The specific amendments proposed in the structure and scope of the groups of the draft revised ISIC, which are given in Part III of the Annex to document E/CN.3/359, are set out in the Annex to this report. The text of this paper indicates the considerations which led to suggesting the major alterations in the structure of the proposed classification. In the course of this discussion, mention is made of certain modifications in the structure of the classification which were suggested by some national statistical offices but which are not proposed. Before dealing with these topics, the text of this paper is devoted to an outline of amendments to, and other improvements in, the underlying principles of the proposed revised ISIC, set out in Part I of the Annex to document E/CN.3/359, which are called for by the consensus of the comments on the classification scheme.

Comments have been received from about 35 countries and 5 international bodies. The Working Group met 8-19 January 1968 in Geneva. See Report of the Meeting 8-19 January 1968, Second session, Working Group on Activity and Commodity Classification, Conference of European Statisticians.

II. UNDERLYING PRINCIPLES OF THE CLASSIFICATION

- 3. The comments on the draft underlying principles of the revised ISIC which are set out in Part I of the Annex to document E/CN.3/359 indicate that the principles are considered to be appropriate and satisfactory. Relatively few modifications or clarifications are required in the description contained in the Part.
- A. Purpose, Nature and Criteria of Construction of the Classification 4. It is now proposed that the two-digit level of the revised ISIC (named sub-divisions in document E/CN.3/359 but divisions here) be used as international guidance in respect of a scheme of classification of enterprise-type units according to kind of economic activity. The discussion in Part I of the Annex to document E/CN.3/359 of the purpose and nature of the classification will therefore need to be altered to indicate this.
- 5. The conclusions reached by the second session of the Working Group on Activity and Commodity Classification also call for amplification of the discussion in paragraph 4 of the Part of the desired comparability between national industrial classification schemes and the ISIC. It should be indicated that it will not always be possible to raise groups in national classifications which coincide with the groups of the ISIC. This may be due to the fact that in a given country the kinds of economic activity covered in one or more groups of the ISIC may not be of sufficient importance to warrant a separate group in the national classification, or may be organized in establishments in a markedly different manner than is portrayed in the international classification. The latter situation may, for example, occur in the case of the industries engaged in fabricating metal products, particularly machinery and equipment, and certain types of repairs of household goods. Very few problems of this type should however arise in respect of the major groups of the revised ISIC.

- 6. The Working Group on Activity and Commodity Classification also recommended that it be indicated in paragraph 15 and other pertinent paragraphs of Part I of the Annex to document E/CN.3/359 that establishments can be expected to carry on secondary types of activity, in addition to their major kind of economic activity.
- B. The Definition and Classification of the Statistical Units 7. If the two-digit level of the revised ISIC is to be used as international guidance in respect of the industrial classification of enterprise-type statistical units, it will be necessary to discuss nature and definitions of these units at greater length than is done in Part I of the Annex to document E/CN.3/359. It will also be essential to include guidance concerning the principles of classifying these units according to kind of economic activity. The comments made in respect of this portion of the underlying principles of the revised ISIC lead to certain amplifications and clarifications in the discussions of the establishment and equivalent units and of ancillary units. In the case of the establishment, or the equivalent local unit, it should be emphasized that the geographic area to be covered in any such unit should at least be restricted to the smallest statistical area for which data are compiled. It is also necessary to call attention to the advantages and importance of delineating the establishment or the local unit in exactly the same way in gathering the various series of data for which this statistical

In the case of ancillary units for purposes of geographic data, attention should be called to the desirability of treating ancillaries located in statistical geographic areas differing from that of the establishments which they serve as distinct statistical units. It will also be useful to discuss the specific problems which may arise in respect of the industrial classification of central administrative offices.

- 10. Specific problems arise in classifying central administrative offices of multi-unit enterprises, the majority of the activities of which do not fall into a single group of a national classification or of enterprises the operating establishments of which are all abroad. The way in which it is considered desirable to classify these central administrative offices differs among countries. In the view of some national statistical offices, such central administrative offices should nonetheless be classified in terms of the predominant kind of activity of their parent enterprise. Other national statistical offices would prefer to raise a special category for such central administrative offices as part of the activity "business services". Still another view is that the special categories might be raised under manufacturing as a whole, wholesale trade as a whole, etc. for purposes of classifying the central administrative offices of enterprises with domestic operating units according to the broad major kind of activity of these enterprises. In this view, it is desirable to provide a distinct special category for the classification of central administrative offices of enterprises with foreign operating units only.
- C. The Decimal Notation and Application of the ISIC

 11. As recommended by the second session of the Working Group on Activity and
 Commodity Classification, it is proposed to alter the names of the one— and
 two-digit levels of the revised ISIC from division and sub-division to major
 division and division, respectively. In accordance with the conclusions of the
 Working Group, the discussion of the application of the ISIC is to give less
 emphasis to constructing national classification schemes from the international
 classification and more emphasis to making national classifications comparable
 with the international classification.

III. STRUCTURE OF THE CLASSIFICATION

12. Certain alterations are suggested in the Annex to this paper in the structure of divisions (two-digit level), major groups (three-digit level) and groups (four -digit level) set out in Part III of the Annex to document E/CN.3/359.

These changes are mainly designed to improve the balance and analytical usefulness of the revised ISIC.

A. The Divisions (Two-Digit Level)

- 13. While some comments on document E/CN.3/359 questioned the introduction of divisions at the two-digit level of classification of the revised ISIC, the large majority of comments welcomed this innovation.
- 14. In the adverse view on the proposed innovation, the two-digit level of the ISIC is considered to be the most important and frequently used level of the classification; and a number of the proposed divisions are thought to be too broad in scope for many analytical purposes. The hierarchy of categories in the present ISIC is also considered to be more suitable for national purposes.
- 15. On the other hand, the favourable comments concerning the proposal to introduce divisions at the two-digit level of the ISIC stress the importance of limiting the number of these categories. It is considered that, as a result, the two-digit level of the classification may be used to present analytically meaningful summary series of classified data; and as international guidance in respect of the industrial classification of enterprise-type units. A number of the national statistical offices which approved of the division indicated that they planned to adopt these categories, or the equivalent, in their industrial classification scheme. The use of the proposed divisions will also facilitate the reporting and compilation of comparable data in respect of all countries centrally planned and market economies, and developed and developing countries.
- 16. As recommended by the Working Group on Activity and Commodity Classification, the following changes are proposed in the two-digit classes of the draft revised ISIC set out in document E/CN.3/359.
 - i. Divisions are added for coal mining and crude petroleum and natural gas production, which in document E/CN.3/359 are major groups of the same two-digit category.

- ii. Divisions are established in the case of wholesale trade and retail trade, which in document E/CN.3/359 are major groups of the same two-digit category.
- iii. Storage and warehousing, which in document E/CN.3/359 is a two-digit category under the same major division as wholesale and retail trade and restaurants and hotels, becomes a group in the major division for transport and communication.
- iv. A new division is raised for international and other extraterritorial bodies under the major division for community, social and personal services, primarily for purposes of providing a category for the industrial classification of employees of these organizations.

B. Major Groups and Groups

- 17. Some alterations are also proposed in the structure of the major groups and groups of the draft ISIC in document E/CN.3/359, primarily in the light of the discussions of the Working Group on Activity and Commodity Classification. The changes consist of the establishment of a few new major groups and groups and some re-ordering of these categories in order to improve the balance and analytical value of the revised classification. Two major groups have also been combined into a single major group in the case of motion picture production and distribution and other entertainment services.
- 18. New major groups have been raised in the case of the division, Manufacture of chemicals and chemical, petroleum, coal, rubber and plastic products, only. The major groups, Manufacture of chemicals and chemical products and Manufacture of products of petroleum and coal, have each been replaced by two major groups. In the case of the chemical manufactures, one major group encompasses the manufacture of basic industrial chemicals, fertilizers and synthetic resins, plastic materials and man-made fibres and another major group covers the manufacture of paints and varnishes, drugs and medicines and other finished chemical products. In the case of petroleum and coal products, petroleum refineries and the miscellaneous products of petroleum and coal make up separate major groups.

- 19. A new group has also been added to the aforementioned division for the manufacture of soaps, cosmetics and toilet preparations in order to reduce the heterogeneity of the group for the manufacture of miscellaneous chemical products. Finally, the order of the major groups within the division has been altered in order to place the manufacture of products mainly for intermediate uses before the manufacture of products primarily for final uses. For the same purpose the order of the major groups in the division for textiles, wearing apparel, leather and leather products has been changed.
- 20. A few new groups have been added in the case of other parts of the draft revised ISIC. The manufacture of chocolates, confectionery and cocoa and chocolate powder and of prepared animal feeds have been segregated into individual groups out of the group for miscellaneous food manufactures. In the case of business services, a new group has been raised for the provision of general data processing and tabulating services on a fee or contract basis; and in the case of social and community services, new groups are proposed for veterinary and religious services, respectively. The new group for veterinary services is associated with the transfer of these services from the major group, agricultural services, to the major group, medical, other health and veterinary services. The transfer was recommended by a majority of the Working Group on Activity and Commodity Classification and in the comments of other national statistical offices on document E/CN.3/359. Raising a separate group for veterinary services will alleviate the disadvantages of the transfer.

C. Repair Services

21. Questions were raised in the comments on document E/CN.3/359 concerning the classification of establishments specializing in the repair of household goods to manufacturing, usually the same group of the ISIC as the establishments manufacturing the kind of goods repaired. In this view, these establishments should be classified to the retail or service trades, depending on where the repair services are mainly performed as a secondary activity. This, it is argued, would bring together in the same category most of each type of repair service, and would avoid distorting the cost structure of various kinds of

manufacturing activity by including repair services. It would also eliminate any danger that year-to-year changes in the relative proportion of receipts from repair works and retail sales might result in changes in the classification of establishments engaged in both types of activity.

- 22. It is nonetheless proposed that the inclusion in manufacturing of establishments specializing in the repair of household goods should be retained. In the centrally planned economies and some other countries, these types of repair services are often associated with the manufacture of the kind of goods repaired. In the developing countries, some of the repair services are linked with custom manufacturing, rebuilding or alteration. The Working Group on Activity and Commodity Classification, recognizing that it is not possible to find a way of classifying establishments specializing in the repair of household goods which fits the circumstances of each country, agreed that the approach to classifying these units taken in the present ISIC should not be altered.
- 23. On the recommendation of the Working Group, it is proposed that the differences between countries in the circumstances under which repairs of household goods are organized, and consequently in the classification of these activities, should be indicated in the discussion of the general principles of classifying repair services in the revised ISIC. It will also be indicated in this discussion that establishments which engage in retail trade and in rendering repair services should be classified to retail trade.
- IV. THE DEFINITION OF THE GROUPS OF THE CLASSIFICATION
 24. As a result of the round of consultations on document E/CN.3/359, changes are proposed in the Annex to this paper in the scope of some of the groups of the draft revised ISIC. These modifications are intended to improve the co-ordination of the international classification with the way in which given kinds of economic activity are organized in a number of countries. Practically all the proposed alterations in the scope of the groups of the ISIC were recommended by the majority of the participants in the Working Group on Activity and Commodity Classification. The comments of national statistical offices on

document E/CN.3/359 also indicated that the definitions in respect of certain groups should be clarified or elaborated. While the instances where the wording of the definitions should be clarified or extended are not discussed in this paper, it is planned that these improvements in the definitions will be made in the publication in respect of the version of the revised ISIC which is approved of by the Statistical Commission.

V. CONCLUSION

25. The comments of national statistical offices indicate that the proposed revised ISIC represents an improvement on the present ISIC. The draft scheme takes account of the manner and pattern in which various kinds of economic activity are carried on in countries differing in economic and social organization and in stage of economic development. It reflects the changes which have taken place in the organization and relative importance of various kinds of economic axtivity and is designed to meet the newer, as well as more traditional, analytical requirements for data classified according to kind of economic activity. The majority of national statistical offices, and international organizations appear to consider the draft revised ISIC suitable and appropriate for use in the compilation and analysis of internationally comparable data.

26. In order to put the revised ISIC to use, national and international statistical offices will need a detailed index to the individual activities covered in each group of the international classification, in addition to a more general description of the structure and composition of the revised ISIC. The values of the detailed index will be greatly enhanced if it also indicates the category of the Standard International Trade Classification, Revised (SITC) to which each of the products characterizing a given group of the revised ISIC is classified. The index will then furnish a revised version of the document, Classification of Commodities by Industrial Origin, as well as the publication, Indexes to the International Standard Industrial Classification of All Economic Activities. 4/

- 27. The Statistical Commission may therefore wish to invite the Secretary-General:
 - i. To prepare a final version of the revised ISIC, based on the Commission's discussions of documents E/CN.3/359 and E/CN.3/360;
 - ii. To circulate to, and call to the attention of, national statistical authorities and the members of the United Nations family of agencies and other international bodies the revised ISIC for use in the reporting and compilation of internationally comparable data; and
 - iii. To prepare numeric and alphabetic indexes to the revised ISIC delineating, inter alia, the links between this classification and the SITC, Revised.
