ADOPTION OF THE AGENDA AND ORGANIZATION OF WORK

State of preparedness of documentation for the session

Note by the Secretariat

- 1. The Economic and Social Council, in its resolutions 1979/1 of 9 February 1979 and 1979/69 of 2 August 1979 on the control and limitation of documentation, reiterated that the Secretariat should circulate the relevant documentation in all the working languages six weeks before the opening of the sessions of the Council and its subsidiary organs, and invited the Secretariat to take steps to ensure effective compliance with rule 13 (4) of the rules of procedure of the Council. By resolution 1979/69, the Council requested the Secretariat "to inform the Council and its subsidiary bodies, in the relevant annotated agenda, which documents have not been issued in accordance with the six-week rule, with a full explanation of the reasons which prevented their circulation".
- 2. In view of the schedule of the session of the Statistical Commission (23 February-4 March 1987), the documentation for the session should have been submitted to the Office of Secretariat Services for Economic and Social Matters by 8 December 1986 and circulated by 12 January 1987. The documents which were not circulated by that date are listed in the annex below. Explanations for the delay will be provided by the office responsible.
