Report of the Rio Group on Poverty Statistics

Purpose

The main objectives of the Rio Group on Poverty Statistics are to harness the experience and concerns of different groups and organizations in the world working on the measurement, interpretation and use of poverty statistics, especially when such work is being done by or in close contact with statistical offices. The identification of the indicators, methodologies and statistical sources being used should allow the preparation of a document or reports containing the state of the art in matters of poverty measurements, common procedures and best practices. Simultaneously, the most important difficulties could be identified and experts working with similar problems and topics could cooperate and thereby improve the quality and relevance of measurements.

Topics considered

Analytical classification of poverty measurements under way by participants; absolute and relative poverty; objective and subjective poverty; poverty indicators and poverty statistics oriented towards policy design and monitoring; within absolute poverty, the poverty line and the unmet basic need methods; methodological and procedural issues more widely used within different measurements of poverty; most important challenges in which participants are working; statistical sources used for poverty measurements; work under way to improve timeliness and quality of sources and estimates; institutional agreements towards comparability of measurements in different regions.

Planned activities (information given before the Lisbon meeting)

Poverty line methodology: thresholds and multipliers; updating; consumption patterns changes; countries regions estimates.

Income measurements: in close coordination with the Canberra Group; equivalence scales; public social expenditures.

Unmet basic needs: thresholds definitions, aggregation problems.

Poverty policies statistics: identification of origins of poverty situations, relation with politics towards vulnerable groups.

Statistical sources: longitudinal surveys, simultaneous use of different sources.

Expected future products (dates)

Due to the fact that the Lisbon meeting will be held at the end of November 1999, an oral presentation will be made at the thirtieth session of the Statistical Commission, in March 2000.
