## **Annotations**

### **1. Election of officers**

In accordance with rule 15 of the rules of procedure and past practice, the Statistical Commission should elect, at its 1st meeting, a Chairman, three Vice-Chairmen and a Rapporteur to serve from the beginning of the thirty-second session of the Commission to the beginning of the thirty-fourth session.

### **2. Adoption of the agenda and other organizational matters**

The items on the provisional agenda and the corresponding documentation were proposed by the Commission at its thirty-first session (New York, 29 February-3 March 2000)<sup>1</sup> and approved by the Economic and Social Council in its decision 2000/228. Some changes have been made, in consultation with the officers of the Commission. A proposed organization of work is before the Commission. The Commission may wish to adopt the agenda and organization of work for the session.

In its decision 2000/228, the Council took note of the report of the Commission and requested it to provide clarification on the issues raised by the Observer for Nigeria (on behalf of the Group of 77 and China) as contained in the summary record of the Council's 41st meeting of its substantive session of 2000 (E/2000/SR.41). The Commission will have before it a note by the Secretariat providing clarification. The Commission may wish to provide the Council with the clarification that it has requested.

### **3. Demographic and social statistics**

#### **(a) Human settlements statistics**

The Commission will have before it a report prepared by the United Nations Centre for Human Settlements on the possible role that the Statistical Commission could play in the preparation of the special session of the General Assembly for an overall review and appraisal of the implementation of the outcome of the United Nations Conference on Human Settlements (Habitat II). Statistics and indicators have been identified by the Commission on Human Settlements acting as the preparatory committee for the special session as a fundamental infrastructure for the monitoring and assessment of the implementation of the Habitat Agenda.<sup>2</sup> It appears that the statistical capacity of national statistical offices is of the utmost importance in achieving comprehensive and reliable assessments of human settlements conditions and trends. In that connection, the United Nations Centre for Human Settlements (Habitat), together with the United Nations Statistics Division, is producing the sixth edition of the *Compendium of Human Settlements Statistics*<sup>3</sup> as an important contribution to the assessment of the implementation of the Habitat Agenda.

The report will also include proposed statistical definitions in connection with a more appropriate enumeration of the homeless. The current definition has turned out to be rather narrow, not allowing meaningful measurement of the phenomenon. During the expert group meeting on the third global report on human settlements, held in Nairobi from 12 to 15 April 1999, a paper was presented introducing the notion of houselessness, which is more comprehensive. Depending on results of ongoing research, the report may also present preliminary definitions for secure tenure and good urban governance, both of which are themes of campaigns that Habitat has launched.

The Commission may wish to:

- (a) Agree on and endorse actions which could promote the implementation of the Habitat Agenda in the key areas of monitoring and assessment;
- (b) Ensure full support for the collection and further development of human settlements statistics, both at the national and city level;
- (c) Endorse proposed new definitions on houselessness, secure tenure and good urban governance.

**(b) Labour statistics supplement to the Tourism Satellite Account**

The Commission will have before it a report prepared by the Bureau of Statistics of the International Labour Organization (ILO), presenting an overview of the main concepts and principles of a labour accounting system (LAS) and a labour accounting system for tourism (LAS-T) linked to the Tourism Satellite Account (TSA). Supplementing the work undertaken by the World Tourism Organization (WTO), the Organisation for Economic Cooperation and Development (OECD) and the Statistical Office of the European Communities (Eurostat) to develop a Tourism Satellite Account<sup>4</sup> to the System of National Accounts, 1993 (1993 SNA),<sup>5</sup> OECD also prepared an “employment module” to TSA (TSA-EM).<sup>6</sup> The objective of TSA-EM was to present a conceptual and methodological framework that links basic employment data with TSA.<sup>7</sup> The objective of the ILO report on LAS and LAS-T is to build on the above-mentioned work as well as on the work undertaken in the ILO and some national statistical agencies to develop a labour accounting system (LAS). An LAS-T will represent a labour statistics-based extension of TSA, and is designed to facilitate the production of TSA-consistent statistics to answer questions about how many and what kind of workers are participating in tourism-related activities (TRA), and how the compensation of employees is being distributed among those TRA workers who are considered to be employees. Thus, the perspective of LAS-T is narrower and more focused than that of TSA-EM. The Commission may wish to comment on the ILO report.

**(c) Gender statistics: progress on time-use surveys**

The Commission will have before it the report of the Secretary-General on progress made on a United Nations Statistics Division project developed with the United Nations Development Programme (UNDP) and the International Development Research Centre of Canada aimed at improving methods and classifications to address gender issues in the measurement of paid and unpaid work. The report will include a proposed outline for a manual on methods for conducting time-use surveys. It will also include as an annex the report of an expert group meeting on methods for conducting time-use surveys, held in New York, from 23 to 27 October 2000, including its comments on the outline for the manual. The Statistical Commission may wish to express its views on the outline for the manual.

**(e) Social statistics**

At its thirtieth session, the Statistical Commission concluded that it would be useful to appoint programme reviewers to review selected programmes in international statistical work; this was seen as involving reporting to the Commission on the current situation regarding a specific programme, identifying gaps and overlaps, progress (or lack of progress), a possible change of focus and other matters. The idea was to ask specific countries to act in the capacity of programme reviewers.<sup>8</sup> At its thirty-first session, members of the Commission considered that one or two programmes might be looked at in a session. The Bureau of the Commission decided to start with one programme, selected social statistics as that programme, and invited Statistics Netherlands to act as the programme reviewer. The Commission will have before it a report prepared by Statistics Netherlands, setting out the method that it proposes for reviewing the social statistics programme. The Commission may wish to review the proposal and decide on a suitable method.

**4. Economic statistics****(a) National accounts**

The Commission will have before it the report of the Task Force on National Accounts (Convener: Intersecretariat Working Group on National Accounts (ISWGNA)). As requested by the Commission, ISWGNA has identified three areas that need to be examined or re-examined to better assess the extent to which countries have implemented the 1993 SNA. Concerning the first two areas, that is, "compliance with 1993 SNA concepts" and "scope of the accounts", ISWGNA makes concrete proposals in its report. Concerning the third area, "quality", some tentative indicators are given but further work and discussion is needed in this area. The report also gives a status report on the topics under discussion through electronic groups and special meetings which might be candidates for updates of the 1993 SNA, such as the treatment of mobile phone licences. As in previous reports, ISWGNA also reviews (i) the integrated presentation of the work programme of the group members in support of implementation of the 1993 SNA, and (ii) the list of handbooks and manuals that are being developed by the city groups and that are related to national accounts.

The Commission will also have before it the report of the Secretary-General, showing the first results of the assessment of countries (based on the new alternative proposed by ISWGNA) regarding the areas "compliance with 1993 SNA concepts" and "scope of the accounts". The report has been prepared in close consultation with the regional commissions, in particular with the Economic Commission for Europe

(ECE) and the Economic Commission for Africa (ECA), which have conducted pilot testing of the new assessment.

The Commission may wish to:

- (a) Decide whether the current milestone assessment should be replaced by the proposed new alternative assessment or should be considered as a supplement;
- (b) Make suggestions on how to encourage more participation in the electronic discussion groups;
- (c) Express its views on the requirements indicated for clearance of manuals and handbooks developed by the city groups related to national accounts;
- (d) Comment on the work programme of ISWGNA.

**5. Natural resources and environment statistics: London Group on Environmental Accounting**

The Commission may wish to review the revision process for SEEA-2000.

**6. Activities not classified by field****(a) International economic and social classifications**

The Commission will have before it the report of the Secretary-General, providing an overview of activities that have been completed to address the Commission's request for action in this area.<sup>11</sup> A progress report on actions taken to update and revise the International Standard Industrial Classification of All Economic Activities (ISIC)<sup>12</sup> and the Central Product Classification (CPC)<sup>13</sup> is contained in the annex to the report, and is based upon the reviews completed and

actions taken by the Technical Subgroup to the Expert Group on International Economic and Social Classifications.

The Commission may wish to respond to the strategy and time-frame set out in the report for the completion of the proposed work programme to update ISIC and CPC by 2002, and for planning their revisions by 2007. The Commission may wish to express its views on:

- (a) The actions proposed by the members of the Technical Subgroup;
- (b) The ways that the key players in the development of international and multinational classifications have been included in the proposed activities for completion by 2002 and 2007;
- (c) The overall organization of the proposed work programme.

**(b) Review of existing statistical programmes in relation to United Nations special years and observances**

The Commission will have before it the report of the Secretary-General on the following four special years or special events to be held in 2002:

- (i) The Third United Nations Conference on the Least Developed Countries;
- (ii) The review of the New Agenda for the Development of Africa;
- (iii) The comprehensive review of Agenda 21;
- (iv) The follow-up to the International Year of Older Persons: Second World Assembly on Ageing.

The possible statistical implications of these events will be briefly analysed, as well as the current situation regarding the provision of relevant statistics. The Commission may wish to decide whether to take up these issues at future sessions, and whether to recommend any specific action in the context of the preparation for these events.

**(c) Coordination of development indicators in the context of the follow-up to United Nations conferences and summits**

The Commission will have before it the report of the Secretary-General on recent developments in the area of indicators, in particular on the outcome of the discussion by the Economic and Social Council at its substantive session of 2000 and Council resolution 2000/27. In paragraphs 8 and 9 of that resolution, the Council made explicit reference to the Statistical Commission and requested the Commission to play a more active role. In particular, the Council requested the Commission to:



- (i) Compile a list of all indicators used in the context of conference follow-up and to technically validate them one by one;
- (ii) Identify a limited number of “common indicators”.

To facilitate the task of the Commission, the report contains a proposed “long” list of indicators; proposed criteria for indicator review; and proposed criteria for the limited indicator “short” list. The Commission may wish to approve the long list of conference indicators as well as criteria for their technical review and for the selection of a limited set. The Commission may also wish to approve the proposed work programme on indicators for 2001 leading to the preparation of a report to the Economic and Social Council in 2002.

The Commission will also have before it a report prepared by the European Commission, the International Monetary Fund, the Organisation for Economic Cooperation and Development and the World Bank on the importance of statistics, indicators and statistical capacity in countries, and the role of the Partnership in Statistics for Development in the Twenty-first Century (Paris 21) in supporting statistical capacity-building in developing countries. The Commission may wish to express its views on how Paris 21 could work with the Statistical Commission to implement Economic and Social Council resolutions 1999/55 and 2000/27 on the integrated and coordinated implementation of and follow-up to the major United Nations conferences and summits.

The

Commission will also have before it a report on the matter prepared by the Human Development Report Office of UNDP. The Commission may wish to endorse the report of the Friends of the Chair and comment on the action and plans of UNDP in relation to the statistical aspects of the *Report*.

The Commission may wish to express its views on the progress achieved and provide suggestions for the improvement of the presentation of the web site.

**(g) Follow-up to the agreed conclusions of the Economic and Social Council's high-level and coordination segments, and to its resolutions**

This item was placed on the agenda by the Commission at the request of the Economic and Social Council (see Council resolution 1999/55). The aims are to encourage a closer relationship between the work of the Commission and that of the Economic and Social Council, and to promote harmonization of the work of the functional commissions of the Economic and Social Council. The Commission will have before it a note by the Secretary-General containing extracts from Economic and Social Council resolutions that are relevant to the work of the Commission and the actions taken or planned by the Commission. The Commission may wish to decide on any action that may be necessary.

It is currently consulting users and producers of statistics internationally and within countries in order to prepare its six-year plan of work to be discussed at the UNESCO General Conference in November 2001 with a view to beginning work at the start of 2002. The Commission will have before it a note from UNESCO outlining its plans, and may wish to express its views on those plans.
