Adoption of the agenda and other organizational matters**Status of documentation for the session****Note by the Secretariat**

1. By Economic and Social Council resolutions 1979/1 and 1979/69 on the control and limitation of documentation and 1988/77 on the revitalization of the Council, the Council reiterated that the Secretariat should circulate the relevant documentation in all the working languages six weeks before the opening of the sessions of the Council and its subsidiary organs, and invited the Secretariat to take steps to ensure effective compliance with rule 13, paragraph 4, of the rules of procedure of the Council. In resolution 1979/69, the Council decided to request the Secretariat to inform the Council and its subsidiary bodies which documents had not been issued in accordance with the six-week rule, with a full explanation of the reasons that had prevented their circulation.

2. In view of the schedule of the thirty-second session of the Statistical Commission (6-9 March 2001), the documentation for that session should have been submitted to the Department of General Assembly Affairs and Conference Services by 20 December 2000 and circulated by 21 January 2000.
