At its 4th meeting, held on 8 December 2021, in accordance with General Assembly resolutions 60/180 of 20 December 2005 and 63/145 of 18 December 2008 and Economic and Social Council resolution 2015/1, the Council elected, by acclamation, LATVIA as a member of the Organizational Committee of the Peacebuilding Commission for a term of office beginning on 8 December 2021 and expiring on 31 December 2022, or until the country ceases to be a member of the Economic and Social Council.

B

At its 9th meeting, held on 16 February 2022, in accordance with General Assembly resolutions 60/180 of 20 December 2005 and 63/145 of 18 December 2008 and Economic and Social Council resolution 2015/1, the Council elected, by acclamation, PORTUGAL as a member of the Organizational Committee of the Peacebuilding Commission for a term of office beginning on 16 February 2022 and expiring on 31 December 2022, or until the country ceases to be a member of the Economic and Social Council.

The final edited text of this decision will be contained in the official records of the Council for 2022 (E/2022/99 (Supplement No. 1)) after editorial review.

C

At its 10th meeting, on 13 April 2022, the Council elected in accordance with General Assembly resolution 60/180 and Economic and Social Council resolution 2015/1, by acclamation, PERU as a member of the Organizational Committee of the Peacebuilding Commission for a two-year term of office beginning on 1 January 2023, or until Peru ceases to be a member of the Economic and Social Council.

As of 1 January 2023, the following six vacancies remain to be filled by the Council: one vacancy each from African States, Asia-Pacific States, Eastern European States and Western European and other States and two additional States members of the Council, all for a two-year term beginning on 1 January 2023.

D

At its 33rd plenary meeting, on 21 July 2022, the Council elected in accordance with General Assembly resolution 60/180 and Economic and Social Council resolution 2015/1, by acclamation, BRAZIL, DENMARK, ITALY and NIGERIA to the Organizational Committee of the Peacebuilding Commission for a two-year term of office beginning on 1 January 2023, or until the country ceases to be a member of the Economic and Social Council.

As of 1 January 2023, the following two vacancies remain to be filled by the Council: one vacancy each from Asia-Pacific States and Eastern European for a two-year term of office beginning on 1 January 2023.
