At its 4th plenary meeting, on 7 December 2022, the Economic and Social Council, in accordance with its decision 1995/223 of 5 May 1995, elected, by acclamation, Belarus, as a member of the Programme Coordinating Board of the Joint United Nations Programme on HIV/AIDS for a three-year term of office beginning on 1 January 2023.

The Council also elected, by acclamation, Australia, for the remainder of the term of office of Canada, beginning on 1 January 2023 and expiring on 31 December 2023.
