Decision text

A

At its 17th plenary meeting, on 5 April 2023, the Economic and Social Council in accordance with Council resolution 1147 (XLI) of 4 August 1966 elected, by acclamation, ARGENTINA, SIERRA LEONE, SLOVENIA, UKRAINE, the UNITED REPUBLIC OF TANZANIA and the UNITED STATES OF AMERICA, as members of the Statistical Commission for a four-year term of office beginning on 1 January 2024.

The Council also elected, by secret ballot, INDIA as a member of the Statistical Commission for a four-year term of office beginning on 1 January 2024.

The newly elected members will fill vacancies occurring on the expiration of the terms of office of BRAZIL, CZECHIA, GEORGIA, KUWAIT, MADAGASCAR, the REPUBLIC OF KOREA, SIERRA LEONE and the UNITED STATES OF AMERICA.

At its 18th plenary meeting, on 5 April 2023, the Economic and Social Council in accordance with Council resolution 1147 (XLI) of 4 August 1966 elected, by drawing of lots by the President, the REPUBLIC OF KOREA as a member of the Statistical Commission for a four-year term of office beginning on 1 January 2024.

As a result, as of 1 January 2024, the Statistical Commission is composed of the following 24 Member States: ARGENTINA^{***}, AUSTRALIA^{**}, BURUNDI^{**}, COLOMBIA^{*}, CUBA^{**}, FINLAND^{**}, GERMANY^{*}, HUNGARY^{*}, INDIA^{***}, JAPAN^{*}, MEXICO^{*}, NETHERLANDS (KINGDOM OF THE)^{**}, REPUBLIC OF KOREA^{***}, RUSSIAN FEDERATION^{**}, SAMOA^{*}, SIERRA LEONE^{***}, SLOVENIA^{***}, SWITZERLAND^{*}, TUNISIA^{**}, UKRAINE^{***}, UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND^{*}, UNITED REPUBLIC OF TANZANIA^{***}, UNITED STATES OF AMERICA^{***} and ZAMBIA^{**}.
