(c) SWITZERLAND, which was to withdraw from the Board effective 31 December 1999, would be replaced by the NETHERLANDS for a term beginning on 1 January 2000 and expiring on 31 December 2001.

#### EXECUTIVE BOARD OF THE UNITED NATIONS DEVELOPMENT PROGRAMME/ UNITED NATIONS POPULATION FUND

The Council elected the following eleven States for a three-year term beginning on 1 January 2000: BELGIUM, BRAZIL, EGYPT, HONDURAS, INDONESIA, JAPAN, NETHERLANDS, RUSSIAN FEDERATION, SWEDEN, TOGO and VIET NAM.

(c) SPAIN, which was to withdraw from the Board effective 31 December 1999, would be replaced by FRANCE for a term beginning on 1 January 2000 and expiring on 31 December 2000.

# INTERNATIONAL NARCOTICS CONTROL BOARD

(d) SWITZERLAND, which was to withdraw from the Board effective 31 December 1999, would be replaced by SWEDEN for a term beginning on 1 January 2000 and expiring on 31 December 2000;

(e) The UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND, which was to withdraw from the Board effective 31 December 1999, would be replaced by ITALY for a term beginning on 1 January 2000 and expiring on 31 December 2000.
