A

At its 4th meeting, on 5 December 2023, the Council in accordance with General Assembly resolution 36/201, elected, by acclamation, GUATEMALA as a member of the Committee for the United Nations Population Award for a term of office beginning on 5 December 2023 and expiring on 31 December 2024.

As a result, as of 5 December 2023, the Committee for the United Nations Population Award is composed of the following nine Member States whose terms of office expire on 31 December 2024:

BULGARIA, CÔTE D'IVOIRE, GUATEMALA, INDONESIA, LEBANON, LIBERIA, MAURITANIA, PORTUGAL and TRINIDAD AND TOBAGO.

As of 5 December 2023, one vacancy remains to be filled on the Committee for members from Latin American and Caribbean States for a term of office beginning on the date of election and expiring on 31 December 2024.

B

At its 12th meeting, on 9 April 2024, the Council, in accordance with the annex to General Assembly resolution 36/201, elected, by acclamation, BURUNDI and GAMBIA as members of the Committee for the United Nations Population Award for a three-year term of office beginning on 1 January 2025.

The newly elected members will fill vacancies occurring on the expiration of the terms of office of BULGARIA, CÔTE D'IVOIRE, GUATEMALA, INDONESIA, LEBANON, LIBERIA, MAURITANIA, PORTUGAL and TRINIDAD AND TOBAGO.

As a result, as of 1 January 2025, the Committee for the United Nations Population Award is composed of the following two Member States whose terms of office expire on 31 December 2027:

BURUNDI, GAMBIA

As of 9 April 2024, the following nine vacancies remain to be filled on the Committee: one member from the Latin American and Caribbean States for a term of office beginning on the date of election and expiring on 31 December 2024; one member from the African States, three members from the Asia-Pacific States, one member from the Eastern European States, two members from the Latin American and Caribbean States, and one member from the Western European and other States, all for a term of office beginning on 1 January 2025 and expiring on 31 December 2027.

At its 38th plenary meeting, on 24 July 2024 the Council, in accordance with the annex to General Assembly resolution 36/201, elected, by acclamation, GUATEMALA as a member of the Committee for the United Nations Population Award for a three-year term of office beginning on 1 January 2025.

As a result, as of 1 January 2025, the Committee for the United Nations Population Award is composed of the following three Member States whose terms of office expire on 31 December 2027:

BURUNDI, GAMBIA, GUATEMALA

As of 24 July 2024, the following eight vacancies remain to be filled on the Committee: one member from the Latin American and Caribbean States for a term of office beginning on the date of election and expiring on 31 December 2024; one member from the African States, three members from the Asia-Pacific States, one member from the Eastern European States, one member from the Latin American and Caribbean States, and one member from the Western European and other States, all for a term of office beginning on 1 January 2025 and expiring on 31 December 2027.
