Appointment of an additional member of the Ad Hoc Advisory Group on Haiti (decision 2025/210 B)

At its 39th plenary meeting on 29 July 2025, the Economic and Social Council, recalling its resolution 2024/20 of 23 July 2024 and its previous resolutions on the work of the Ad Hoc Advisory Group on Haiti and its decision 2025/210 of 16 December 2024 and previous decisions on the membership on the Ad Hoc Advisory Group, and having considered the letter dated 17 February 2025 from the Permanent Representative of Paraguay to the United Nations addressed to the President of the Council, decided to appoint the Permanent Representative of Paraguay to the United Nations as an additional member of the Ad Hoc Advisory Group on Haiti.

As a result, as of 29 July 2025, the Ad Hoc Advisory Group on Haiti is composed of the Permanent Representatives of Argentina, Bahamas, Barbados, Belize, Benin, Brazil, Canada (Chair), Chile, Colombia, Costa Rica, the Dominican Republic, El Salvador, France, Germany, Guatemala, Haiti, Italy, Jamaica, Kenya, Mexico, Paraguay, Peru, Saint Kitts and Nevis, Saint Vincent and the Grenadines, Spain, Suriname, Trinidad and Tobago, the United States of America and Uruguay.
