At its 14th plenary meeting, on 4 April 2025, the Economic and Social Council, in accordance with General Assembly resolution 48/162, elected, by acclamation, ARMENIA, BOLIVIA (PLURINATIONAL STATE OF), CHINA, CUBA, ESTONIA, FINLAND, JAPAN, NEPAL, NORWAY, RWANDA and UNITED STATES OF AMERICA as members of the Executive Board of the United Nations Development Programme/United Nations Population Fund/United Nations Office for Project Services for a three-year term of office beginning on 1 lanuary 2026.

- The newly elected members will fill vacancies occurring on the expiration of the terms of office of AUSTRALIA, CHINA, COLOMBIA, ECUADOR, ETHIOPIA, JAPAN, NORWAY, REPULIC OF KOREA, REPUBLIC OF MOLDOVA, SLOVAKIA and UNITED STATES OF AMERICA.
- The Council also elected, by acclamation, MONACO, NEW ZEALAND and TÜRKIYE for the remainder of the terms of office of AUSTRIA, LUXEMBOURG and IRELAND, respectively, beginning on 1 January 2026 and expiring on 31 December 2026; and SWITZERLAND for the remainder of the term of office of BELGIUM beginning on 1 January 2026 and expiring on 31 December 2027.
